- 2. From 1998 to present, I have been the Managing Partner of the partnership trading as HWL Ebsworth Lawyers (**HWLE**).
- 3. HWLE is a full service commercial law firm with offices in Adelaide, Brisbane, Canberra, Darwin, Hobart, Melbourne, Norwest, Perth and Sydney.
- 4. In my role as Managing Partner of HWLE, I am the person with ultimate responsibility for signing contractual documents on behalf of HWLE.
- On 23 June 2021, I had a discussion with Kris Hopkins, Chief Operating Officer of HWLE, in my office, who said to me in words to the following effect:
 - **KH**: "It appears as if Forum has fraudulently executed contracts on our behalf using our signatures".
- 6. The reference to "our signatures" in the conversation deposed to at paragraph 5 above, was a reference to my and Kris Hopkins signatures for HWLE.
- 7. I was provided with a copy of the documents to which I refer in paragraphs 8 to 11 below by Mr Hopkins.
- 8. At pages 1 to 19 of JM-1 are copies of documents with the following descriptions:

(a) Customer Payment Schedule dated 23 August 2018 for the purchase of 38 INEO + 658 and 38 INEO + 754e; CB.F.I.1 pF.I.3 Ln 3

- (b) Customer Payment Schedule dated 22 February 2019 for the purchase of 32 Develop ineo +759; CB.F.I.1 pF.I.13 Ln 22
- (c) Customer Payment Schedule dated 13 June 2019 for the purchase of 19 INEO + 659; and CB.F.I.1 pF.I.18 Ln 28

 - (a) A letter from Forum Finance Pty Ltd to me dated 7 September 2018 in relation to the Payment Schedule dated 23 August 2018 ; CB.F.I.1 pF.I.3 Ln 3
 - (b) A letter from Forum Finance Pty Ltd to me dated 1 March 2019 in relation to the Payment Schedule dated 22 February 2019; CB.F.I.1 pF.I.13 Ln 22
 - (c) A letter from Forum Finance Pty Ltd to me dated 18 June 2019 in relation to the Payment Schedule dated 13 June 2019; CB.F.I.1 pF.I.18 Ln 28
 - (d) a letter from Forum Finance Pty Ltd to me HWLE dated 24 July 2019; and CB.F.I.1 pF.I.22 Ln 34

- 11. At page 29 of JM-1-is an undated letter from NMF and Forum Finance Pty Ltd to HWLE purporting to be a notice of assignment (the NMF Letter). CB.F.I.1 pF.I.22 Ln 34
- 12. Each of the Payment Schedules and Delivery Certificates include an acknowledgment purportedly for and on behalf of HWLE with a signature above my name. The signatures appear to be in handwriting and not an electronic signature.
- The signatures on the Delivery Certificates purport to be witnessed by either Aaron Elliott (the Head of Information Technology at HWLE) or Bill Papas.
- 14. The signatures purporting to be mine in the Payment Schedules and Delivery Certificates are not mine.
- 15. The occasion on which I first saw the Payment Schedules, the Delivery Certificates, the Forum Letters and the NMF Letter was when Mr Hopkins provided them to me on 23 June 2021. During the conversation deposed to at paragraph 5 above, I told Mr Hopkins that the signatures appearing on those documents were not mine.
- In my role as Managing Partner of HWLE, I have access to the books and records of HWLE. I know from reviewing the books and records of HWLE that:

- HWLE has not entered into the arrangement with respect to the goods referred to by serial number in the Payment Schedules;
- (b) the goods referred to by serial number in the Payment Schedules have not been delivered to HWLE; and
- (c) HWLE has not made lease payments on those goods.
- 17. I have also caused a search of the books and records of HWLE and that search has not located within those records, the original or a copy of the Payment Schedules, the Delivery Certificates, the Forum Letters, or the NMF Letter.
- The only legitimate agreements between HWLE and NMF or Forum Finance are as follows:
 - three agreements styled as "Corporate and Government Print Plan Management"
 between NMF and HWLE dated 28 June 2016 (at pages 30 to 53 of JM-1); WES.5004.0001.0099
 - (b) an agreement styled as a "Print Services Plan" between Forum Finance and
 HWLE dated 22 February 2019 (at pages 54 to 59 of JM-1); and WES.5004.0001.0129
 - (c) an agreement styled as a "Print Services Plan" between Forum Finance and HWLE dated 1 October 2020 (at pages 60 to 66 of JM-1). WES.5004.0001.0122
- In the course of preparing this affidavit, I was also provided with the following documents (copies of which are at pages 67 to 107 of JM-1): WBC.5000.0001.0431
