#### Grounds of appeal

- The Primary Judge erred in not finding that the State of Queensland and its agents were afforded protection at common law from civil liability, in circumstances in which they acted in obedience to an order for imprisonment and a warrant issued by the Federal Circuit Court, and both the order and warrant appeared lawful on their face.
- 2. The Primary Judge erred in holding that, as a matter of construction, s 249 of the *Criminal Code* (Qld) did not apply to a warrant issued by the Federal Circuit Court.
- 3. The Primary Judge ought to have held that ss 247, 249 and 250 of the Criminal Code (Qld) applied to the actions of the officers of the Queensland Police Service and Queensland Corrective Services taken in execution of the warrant and the order for imprisonment.

#### Orders sought

- 1. The appeal be allowed.
- 2. Orders 2, 4 and 6 made on 30 August 2023 be set aside insofar as they relate to the appellant and, in lieu thereof, order that:
  - a. the first respondent's claim for damages against the appellant be dismissed;
  - b. the first respondent pay the costs of the proceeding before the Primary Judge and the costs of the appeal.
- 3. Such further or other orders the court considers appropriate.
