- 6. An order that the Receivers are justified in paying their remuneration costs and expenses approved by the Court in the sum of \$188,017.84 from the Receivers' Trust account.
- 7. An order that Anthony Koletti be required to allow the Receivers access to the Dover Heights
 Property (including all rooms, cupboards and / or locked receptacles located at the Dover
 Heights Property) on the terms proposed in the Schedule 6 to this Amended Interlocutory
 Process for the purpose of inspecting the condition of the property, identifying any urgent
 repairs that may be required, and to take an inventory of assets, fixtures and fittings at the
 Dover Heights Property.
- 8. Within 7 days from the earlier of the filing of a concise statement in accordance with Order 10 or an application being made in accordance with Order 13, Anthony Koletti shall, until further order, allow the Receivers access to the Dover Heights Property (including all rooms, cupboards and / or locked receptacles located at the Dover Heights Property) for the purpose of inspecting the condition of the property, identifying any urgent repairs that may be required, and to take an inventory of assets, fixtures and fittings at the Dover Heights Property, such access to be exercised as follows:
 - a. The Receivers are entitled to obtain access to the Property at intervals of not less than 21 days;
 - b. Access is limited to Bruce Gleeson and 1 other person being either a staff member of Jones Partners or a security guard, that person to be selected by Bruce Gleeson in his discretion:
 - c. Access must be between the hours of 9am and 5pm on a business day in New South Wales; and
 - d. The Receivers are to provide not less than 3 business days' notice to Anthony Koletti of the time at which they propose to seek access to the Property by sending such notice by way of email to Anthony Koletti at the email address
- 15. Pursuant to section 37AF(1) of the *Federal Court of Australia Act 1976* (Cth), until further order, the publication or disclosure of the affidavits of Michael Kevin Hayter filed in support of the amended interlocutory application of Bruce Gleeson and Daniel Soire in their capacity as receivers of the property of Melissa Louise Caddick dated 18 February 2022, insofar as they refer to the name of the son of the first defendant and the addresses of properties included in the definition of Real Property in the third further amended originating process filed by the Australian Securities and Investment Commission on 23 November 2021, is prohibited other than to the parties to this proceeding and each of their legal representatives.

- 16. Pursuant to section 37AF of the *Federal Court of Australia Act 1976* (Cth), the published form of these orders contain the redactions as shown in <u>underline</u> in the draft orders submitted to the Court.
- 17. That leave be granted to the Receivers to file the Interlocutory Application.
