I, PETER HEINZ VIELHAUER, Public Servant, care of the Department of Mines, Industry Regulation and Safety, 100 Plain Street, East Perth in the State of Western Australia, declare and affirm:

1. I am currently employed as the Team Leader, Title Compliance, Resource and Environmental Compliance Division within the Department of Mines, Industry Regulation and Safety (**DMIRS**) within Western Australia.
2. I have worked at DMIRS for the past 42 years and held a number of roles within the Department. Those roles have included various roles within the Resource Tenure Division and the Resource and Environmental Compliance Division within DMIRS.
3. DMIRS is, amongst other things, the department responsible for managing Western Australia's mining, petroleum and geothermal industries and maintains the State's official register of mining, petroleum and geothermal titles.
4. In this affidavit, I include in any reference to DMIRS, reference to DMIRS's predecessors, including the Department of Mines, the Department of Minerals and Energy, the Department of

Mineral and Petroleum Resources, the Department of Industry and Resources and the Department of Mines and Petroleum.

5. In my role as Team Leader, Title Compliance, I manage a team responsible for ensuring rents are paid on a timely basis. In my role, I also ensure that payments adhere to the requirements in the *Mining Act 1978* (WA) (**Mining Act**) and the *Mining Regulations 1981* (WA) (**Mining Regulations**).
6. Unless stated otherwise I affirm this affidavit on the basis of facts which have come to my knowledge, including facts which have come to my knowledge from my examination of records maintained by DMIRS and, where specified, information provided by other State government departments. Where I rely on facts outside my personal knowledge, I have identified the source of those facts and believe them to be true.

#### REQUEST FOR RENT INFORMATION

7. On 22 September 2023, I received an email from the State Solicitor's Office (SSO) requesting that I review information held by DMIRS with respect to the following mining tenements to determine the total amount of rent paid since the grant of each of the tenements, on a per tenement basis:

**RENT UNDER THE MINING ACT 1978 (WA)**

8. Section 108 of the Mining Act provides that rent is payable by the holder of a mining tenement at the rates and times prescribed.
9. Regulation 109(3) of the Mining Regulations provides that the prescribed rent for a mining tenement for a year is the rent for a mining tenement of that kind set out in Schedule 2 to the Mining Regulations. The rate of rent therefore depends on the kind of mining tenement.

10. The annual rent of a mining lease is currently determined per hectare or part of 1 hectare at the rate set out in Item 8 of Schedule 2 to the Mining Regulations.
11. The annual rent of a miscellaneous licence is currently determined per hectare or part of 1 hectare at the rate set out in Item 4 of Schedule 2 to the Mining Regulations.
12. The annual rent of an exploration licence that was applied for on or after 28 June 1991 is currently determined per block at the rate set out in Item 2 of Schedule 2 to the Mining Regulations. The annual rent of an exploration licence that was applied for before 28 June 1991 is determined at a different rate. However, all of the exploration licences listed in paragraphs 7(z)-7(gg) fall into the first category. As set out in Item 2 of Schedule 2, the annual rate of rent for an exploration licence increases in the fourth, sixth and eighth years of the term of the licence.
13. The annual rent of a prospecting licence is currently determined per hectare or part of 1 hectare at the rate set out in Item 5 of Schedule 2 to the Mining Regulations.
14. It is DMIRS's practice to review rents annually on 1 July.
15. Regulation 64(1C) of the Mining Regulations provides that an application for a mining tenement must be accompanied by the annual rent set out in Schedule 2 to the Mining Regulations that applies to that kind of tenement. Subsequently, regulation 109(4) of the Mining Regulations provides that rent is payable yearly in advance within one month after the anniversary of the date on which the term of the tenement commenced.

#### **DMIRS SYSTEM FOR RECORDING RENT**

16. Mining tenement applications and grants, as well as any transfers, mortgages, caveats and other dealings and conditions affecting the land that is the subject of a mining tenement are recorded by DMIRS in the Official Register. The Official Register also records all rental payments made in respect of each mining tenement ('rental payments'), as well as any refunds paid to the holder of the mining tenement ('refunds').
17. Prior to 2 April 2001, the Official Register was a hard copy tenement register. Since 2 April 2001, an electronic register, known as the Electronic Mineral Titles System (eMiTS), progressively became the Official Register with full State coverage released on 5 May 2003. Officers within DMIRS continually update the information contained within eMiTS to correct errors or enter missing information which may have been incorrectly entered into eMiTS from the old hard copy Official Register.

18. Rental payments can be made online or in person at a mining registry. Online payments are made through the payments portal on the DMIRS website. DMIRS Financial Integration Layer is a system that links eMiTS to the DMIRS payment system to allow electronic payments. Online rental payments can be deposited directly into the DMIRS bank account or by using EFT through the payer's bank. When rental payments are made online, the payment appears in eMiTS after the payment is processed. When rental payments are made at a mining registry, the officer enters the payment number in Retail Touch (the cash register) and it is then entered into eMiTS automatically.
19. Various reports can be generated within eMiTS, including a 'Bulk Payment/Refund Report'. A Bulk Payment/Refund Report can be generated on a per tenement basis, and contains information relating to all rental payments and all refunds in respect of that mining tenement.

## **REFUNDS**

20. Refunds may be paid to the holders of mining tenements for a number of reasons. The following are the reasons why various refunds have been paid in respect of some of the mining tenements listed at paragraph 7 above.
21. The area of a mining tenement may be reduced on survey. Each mining tenement is officially surveyed under the Mining Act, and if the net area on survey is less than the area applied for, then the holder is entitled to a refund of rent for the difference in area.
22. A mining tenement may be granted over an area that is less than the area that was applied for. For instance, an application may be made for an area that is a certain amount of blocks or hectares. If, however, fewer blocks or hectares are granted, the holder is entitled to a pro rata refund of the rent for those blocks or hectares that are not granted.
23. Where the holder of a prospecting licence or an exploration licence has applied for a mining lease pursuant to section 49 or section 67 of the Mining Act and a lease is granted over the whole of the prospecting licence or exploration licence area, the applicant is entitled to a pro rata refund of the balance of any portion of unused rent which has been paid on the prospecting licence or exploration licence that was formerly held. This is known as 'converting' the licence.
24. Alternatively, where the holder of a prospecting licence or an exploration licence has applied for a mining lease pursuant to section 49 or section 67 of the Mining Act and a lease is granted over part only of the prospecting licence or exploration licence area, the applicant is also entitled to a refund of the rent in relation to the 'converted' part of the prospecting licence or exploration licence.



25. Where the holder of an exploration licence and another mining tenement applies to amalgamate the two tenements and the application is granted, the holder is entitled to a pro rata refund of rent paid on the other mining tenement.
26. If the holder of a mining lease surrenders the lease in whole or in part conditionally upon the grant of a mining tenement in respect of the whole or any part of the lease and that mining tenement is granted, the holder is entitled to a pro rata refund of rent paid on the whole or such part of the lease as is included in the mining tenement for the period commencing on the day on which the tenement is granted.
27. Adjustments may be made to allow for GST. GST was collected on mining tenements between 2 February 2001 and 30 June 2011 because of Commonwealth legislation. GST was 1/11th of the total rent paid. Therefore, any refunds relating to rental payments that were made between 2 February 2001 and 30 June 2011 (when GST was collected on mining tenements) always included a GST component. This was the case even if the refunds were paid after 30 June 2011.
28. The holder of a mining tenement may pay more rent than is due to be paid. In this case, DMIRS refunds to the holder of the tenement the amount by which they have overpaid.

#### **BULK PAYMENT/REFUND REPORTS**

29. To generate a Bulk Payment/Refund Report, I access eMiTS and generate a report through the "Payment/Refund Maintenance" tab for an individual tenement to determine the rent and refunds paid on it.
30. Attached to my affidavit at annexures PHV-1 to PHV-36 are the Bulk Payment/Refund Reports in respect of each of the mining tenements listed in paragraph 7 above.
31. The following features are notable in the Bulk Payment/Refund Reports. I refer to the Bulk Payment/Refund Report in respect of E 47/1333-I (Annexure PHV-27) by way of example.
  - (a) The fifth column in the Bulk Payment/Refund Report is headed 'Payment/Refund', and the data in the fifth column records which kind of transaction it was. For example, in Annexure PHV-27, the first listed transaction (lodged 1 August 2023) is recorded as a 'payment', whereas the third listed transaction (lodged 5 April 2022) is recorded as a 'refund'.
  - (b) The seventh column in the Bulk Payment/Refund Report is headed 'MR Paid'. The 'MR' stands for 'Mining Registry', and the data in the seventh column records the registry at which the transaction was paid. For example, in Annexure PHV-27, the first listed transaction (lodged 1 August 2023) is recorded as being 'online', whereas the last listed transaction (lodged 18 November 2003) is recorded as being at Karratha.





- (c) The eighth column in the Bulk Payment/Refund Report is headed 'Amount Paid' and the data in the eighth column records the amount involved in each transaction. The data in the eighth column does not (of itself) indicate whether the 'amount paid' was a payment or a refund. For example, in Annexure PHV-27, the 'amount paid' in the third listed transaction (lodged 5 April 2022) is recorded as \$1,184.75 even though this was a refund to the holder of the tenement.
- (d) At the end of the list of transactions in the Bulk Payment/Refund Report, the 'total payments received' and the 'total amount refunded' is recorded. For example, in Annexure PHV-27, the 'total payments received' is recorded as \$377,280.56, and the 'total amount refunded' is recorded as \$2,071.78.
- (e) The final section of the Bulk Payment/Refund Report provides a 'summary for rent fees'. The final amount in the left hand column of this section records the total rent kept by DMIRS. For example, in Annexure PHV-27, the total rent kept is recorded as \$375,208.78.

#### **CALCULATION OF TOTAL RENT**

32. The total rent kept by DMIRS is equal to the sum of all rental payments, less the sum of all refunds ('total rent'). The total rent for any given mining tenement is calculated with respect to the whole of the tenement. In accessing the records in eMiTS relating to the rental payments for each of the mining tenements listed in paragraph 7 above, I have not had regard to the extent to which any particular mining tenement overlaps the area the subject of the Solomon Hub project.
33. Below is a table setting out the total rent kept by DMIRS in relation to each of the tenements listed in paragraph 7 above.


