2. Within this affidavit, where I have referred to "Video Material", I am describing audiovisual footage of the incident on 15 April 2024, during which a teenage male stabbed Bishop Mar Mari Emmanuel in a church in Wakeley, New South Wales. When I refer to having viewed the Video Material, I am referring to having viewed at least the actual moments where Bishop Mari Mari was stabbed.

Within this affidavit, where I have referred to Video Material as "Uncensored", I mean that the Video Material is not edited to prevent viewers from seeing the stabbing, and also that no post-production video effect has been applied to the Video Material for the purpose of covering, concealing or blurring the depiction of Bishop Mar Mari Emmanuel being stabbed.

Internet Searches Undertaken

- 4. On 30 April 2024, I instructed Mr Jonathan Lin Wei Li, a graduate solicitor employed by Thomson Geer, to conduct internet searches using the search terms:
 - (a) Sydney Church Stabbing;
 - (b) Mar Mari Emmanuel Stabbing; and
 - (c) Sydney Bishop Stabbing.
- On 2 May 2024, Mr Li sent me an email, which summarised the steps he took in conducting the searches and provided me with a list of URL hyperlinks. Now presented to me and marked "JHQ1" is a true copy of the email from Mr Li to me dated 2 May 2024.
- 6. I was able to access Uncensored copies of the Video Material by clicking on the links using the following 26 URLs:



Instructions

You have asked me to conduct internet searches on various websites and online platforms to see if the live stream footage from 15 April 2024 is accessible.

Summary

Between 30 April and 2 May I have been looking on websites and online platforms for videos which depict the stabbing of Bishop Mar Mari Emmanuel on 15 April 2024.

I have kept track of my time, and can say that I have spent approximately 8 hours on this task.

I have reviewed 26 instances of the stabbing video online. None of these videos have any form of censorship or blurring/pixilation applied.

I have screenshotted all these websites and platforms containing these uncensored videos and saved them.

Searches

Where the websites/online platforms were in English, the search parameters I used to obtain these videos were:

- Sydney Church Stabbing
- Mar Mari Emmanuel Stabbing
- 3. Sydney Bishop Stabbing

Where the websites/online platforms were in Chinese, I used Google Translate to input the above search phrases.

Where the websites/online platforms were in Russian, I obtained the help of Nikita Sosnik, a Law Graduate who speaks Russian, to help input the above search phrases.

- DuckDuckGo (a popular search engine alternative to Google)
- Dailymotion
- Telegram
- 8. Douyin (this is the Chinese equivalent to Tik Tok)

- 11. 9Gag (social media site used to share memes and funny video clips)
- 12. Rumble (similar to Youtube)
- 13. VK (similar to Facebook)
- Gettr (similar to TikTok/Instagram)
- 15. WeChat (like Chinese Whatsapp)

I am very confident that if I were to search for longer or on different platforms I would be able to find further examples of where the video is available to be viewed in Australia without a VPN.
