- 2. I am currently Managing Director at a subsidiary of a large ASX listed company that focusses on environmental sustainability. I have been in this role since September 2020.
- From July 2018 to September 2020, I was the Chief Strategic Development & Innovation Officer for Veolia Environmental Services (Australia) Pty Ltd ACN 051 316 584 (Veolia) and Veolia Environmental Services (NZ) Limited NZBN 9429038358623 (Veolia NZ).
- 4. From January 2014 to July 2018, I was the Executive General Manager, Central / Western Australia and New Zealand for Veolia and Veolia NZ.
- 5. Veolia and Veolia NZ are in the business of waste management, water and energy. Part of Veolia Australia's business involves using waste digesters to transform solid organic waste into liquids. Veolia NZ did not use these services.
- 6. From 11 November 2015 to 31 August 2020, I sat on the board of directors for Veolia NZ. The Board of Veolia NZ primarily performed statutory functions. Operational decisions were made by the Country Director of Veolia NZ with delegation through to the CEO of Veolia and Veolia NZ. A copy of a company search for Veolia NZ is at pages 1 to 13 of LK-1. I have never been a director of Veolia.
- 7. In my role as Executive General Manager, Central / Western Australia and New Zealand for Veolia and Veolia NZ, I was responsible for Veolia NZ's operations. My operational responsibility in Veolia NZ ended once I commenced as Chief Strategic Development & Innovation Officer (July 2018), at which time my role in Veolia NZ only involved attending board meetings.
- 8. Although I had delegated authority to sign certain contractual documents on behalf of Veolia and Veolia NZ, it was not my practice or part of my role in relation to Veolia or Veolia NZ to sign supplier or minor contractual agreements. Further, it was the practice for the Veolia NZ Country Manager to execute supplier and contractual documents, in accordance with the Veolia NZ Delegation of Authority.

Background to Relationship with Forum

9. My first involvement with Bill Papas and Tas Papas was when I was Executive General Manager, Central / Western Australia and New Zealand. On 18 July 2018, I was copied to an email sent from Preet Brar (CFO of Veolia and Veolia NZ) to Tas Papas in which Preet said that Veolia was interested in collaborating with Forum regarding ORCAs and that she would leave it to me to progress the discussions between Veolia and Forum. A copy of that email (SEC.5000.0031.6733) is at page 14 of LK-1.

- 10. I was involved in some of the initial discussions and negotiations between Veolia and Forum regarding a Distribution Agreement for the supply of ORCA waste digestion units to Veolia (**Distribution Agreement**). Under the terms of the Distribution Agreement, Veolia acquired the rights to enter into contracts for the supply of ORCAs with third parties (including the rights to eventually sell the ORCAs to those third parties after a trial period).
- On 19 December 2018, I signed the Distribution Agreement for an on behalf of Veolia and my signature was witnessed by Charlie Crane (Commercial Manager (Strategic Projects) for Veolia. A copy of the Distribution Agreement (<u>SEC.5000.0043.3021</u>) is at pages 15 to 36 of LK-1.
- 12. Although I had some initial discussions in relation to the establishment of the Distribution Agreement, it was not part of my role to be involved in the day-to-day processes under the Distribution Agreement (including the process by which the ORCAs were to be obtained or leased from Forum and supplied to third parties). The Veolia Legal team reviews distribution agreements before approval and sign off. Day to day sales transactions were done by the Sales Team at Veolia, principally Arif Chowdhury, who was the designated Veolia representative for ORCAs, and the Waste leadership team.
- 13. The person I had the most involvement with regarding ORCAs was Tas Papas. I had met Bill Papas, although I had less to do with Bill.
- 14. On 4 April 2019, I attended a coffee meeting at the lobby of the Hyatt Regency Sydney with Bill Papas, Tas Papas, and representatives from Westpac's Leasing Team. I was advised the purpose of the meeting was an introductory one and to discuss Veolia's activities and strategic focus areas. The site was one which was using ORCA digesters. A copy of Google Calendar appointment invitation I received from Bill Papas (SEC.5000.0046.3260) together with my response accepting the invitation (SEC.5000.0046.3259) is at pages 37 to 38 of LK-1. Although I cannot now precisely recall what was discussed, I recall that I spoke about the niche markets that Veolia was hoping to focus on (such as hotels and restaurants) for the ORCAs. I also explained the difference between large scale organics processing facilities that Veolia operated and the niche markets for digesters. It was a high level introductory meeting that lasted approximately 30 minutes as I had another appointment.
- 15. I also recall that shortly before I finished working within the Veolia group, I had a discussion with Tas Papas in relation to Surfacide units (which were units that could disinfect surfaces or premises following a COVID-19 exposure). I recall that Veolia

agreed to trial a small number of these units, although I do not recall if we signed any formal agreement with lugis Pty Ltd (which was the Forum company I recall was involved with these units) in relation to this trial. I did not order any Surfacides other than this trial arrangement and did not organise any repeat purchase orders for the Surfacide units. I also do not recall whether there were any Surfacide units trialled or purchased through or for Veolia or Veolia NZ.

- 19. I have reviewed each of the signatures purporting to be mine on the Payment Schedules and on the Delivery Certificates. The signatures purporting to be mine on each of the Payment Schedules and Delivery Certificates are not mine.
- Each of the Payment Schedules and Delivery Certificates identify my role as being either "COO", "CFO" or "Director" of Veolia or Veolia NZ. Other than my role as a Director of Veolia NZ, I have never held any of those titles, nor signed anything with these titles.
- 21. With respect to the agreements purportedly entered by Veolia NZ, Veolia NZ's business, at the time I was employed with the Veolia group, was concerned almost exclusively with water and energy. To the best of my recollection, the extent of Veolia NZ's waste operation during the period I was employed within the Veolia group was a single contract with the Auckland City Council for municipal waste collection. Other than that contract, Veolia NZ had no business in waste management and had no need or market for waste digestors. Veolia briefly explored the possibility of a market for New Zealand for digesters (done by the Country Director Alex Lagny and development manager Keith Martin) but they came to the conclusion that there was no business case and nothing eventuated.
- 22. The first time I saw the Payment Schedules and the Delivery Certificates was in the process of preparing this affidavit.
- 23. I have also been provided with a bundle of letters supposedly transferring title to the goods referred to in the Customer Payment Schedules from Forum Finance Pty Ltd to Veolia or Veolia NZ. At pages 385 to 451 of LK-1 is a bundle of those letters as summarised in the table below (the Forum Letters):
