#### OPENING

Mr Vaughan Strawbridge, a Joint and Several Administrator of the Companies, opened the meeting at 11.01AM.

Mr Strawbridge welcomed those in attendance to the First Meeting of Creditors of Virgin Australia Holdings Limited and the 37 subsidiaries subject to Voluntary Administration (the **Companies** or **Virgin Group**).

#### CHAIRPERSON

Mr Strawbridge introduced himself as one of the four (4) Joint and Several Administrators of the Companies and advised he would act as Chairperson of the meetings pursuant to rule 75-50 of the *Insolvency Practice Rules (Corporations) 2016 (IPR)*.

#### INTRODUCTIONS

The Chairperson introduced:

- Messrs Sal Algeri, Richard Hughes and John Greig, his fellow Joint and Several Administrators who were in attendance virtually;
- Mr Timothy Sackar of Clayton Utz, who are engaged as legal counsel for the Administrators; and
- advised that various other members of Deloitte staff working on the voluntary administration were also in attendance virtually.

#### MEDIA

The Chairperson asked that any members of the media who were not creditors of the Companies exit the meeting.

#### CONCURRENT MEETINGS OF CREDITORS

The Chairperson referred to the listing of 38 Virgin companies subject to Voluntary Administration (**Annexure A**), which was displayed at the meeting and made available on the Voluntary Administration website: [www.deloitte.com/au/virgin](http://www.deloitte.com/au/virgin)

The Chairperson advised the meetings for the Companies would be held concurrently, as indicated by the Notice of the First Meetings of Creditors dated 21 April 2020. The Chairperson advised there had been no objections or concerns raised by creditors to the meetings being held concurrently.

The Chairperson asked that any objections to the meetings being held concurrently should be raised in writing to [virginadmin@deloitte.com.au](mailto:virginadmin@deloitte.com.au).

#### AGENDA AND CONDUCT OF THE MEETING

The Chairperson outlined the agenda for the meeting, as follows:

Opening:

- COVID-19 and its effect on the Administration
- Meeting formalities
- Purpose of the meeting
- Declaration of Independence, Relevant Relationships and Indemnities (**DIRRI**)

Administration:

- Orders made by the Federal Court on 24 April 2020
- Role of the Administrator
- Actions since appointment
- Restructure of the business
- Questions – received from registration form
- Committee of Inspection
- Questions – live Q&A
- Closure

The Chairperson advised that due to the threat of the COVID-19 pandemic, and consistent with Government policy on gatherings, the Administrators were not able to conduct a meeting of this size and significance at a physical venue. As such, webinar facilities had been established to facilitate attendance at the meeting. The Chairperson advised the meeting was being conducted within the guidelines established by the *Australian Securities and Investments Commission (ASIC)* for holding meetings during COVID-19 restrictions.

ATTENDANCE REGISTER

The Chairperson advised that as of 9:00AM (AEST), registrations to attend the meeting had been received from 768 creditors and 568 observers.

The Chairperson noted that those creditors and observers who registered to access the meeting webcast will be recorded on the attendance registers (refer Annexures B & C).

The Chairperson noted that observers were unable to participate in the creditors meeting by asking questions.

The Chairperson advised that for the purposes of this meeting, all submitted proofs of debt had been accepted. However, the Chairperson noted that the Proofs of Debt would be subject to a formal review; further noting that the position may change at the second meeting.

The Chairperson reiterated that he intended to hold the Companies' meetings concurrently and asked if there were any objections to this. There were no objections.

NOTICE OF MEETING

The Chairperson advised that the meeting had been called in accordance with the Notice of the First Meeting of Creditors dated 21 April 2020, which was distributed to creditors as an enclosure to the *Initial Notice to Creditors* dated 21 April 2020, and subsequently recirculated to creditors in the Administrators' *Circular to Creditors* dated 27 April 2020. The Notice of the First Meeting of Creditors was simultaneously advertised on ASIC's Published Notices Website on 21 April 2020, available at <https://insolvencynotices.asic.gov.au/>.

DECLARATION OF CONVENIENCE

The Chairperson advised the Administrators had not received any objections to the time and place of the meeting prior to the concurrent meetings having commenced. The Chairperson therefore declared the meeting to be held at a date, time and place convenient to the majority of persons entitled to receive the notice of the meeting and in accordance with rule 75-30 of the IPR.

PROXIES

The Chairperson advised the Administrators had received 6,924 proxies for creditors of the Virgin entities for which this concurrent meeting is held.

Given the significant number of proxies received, it is impractical for me to read these out to the meeting.

QUORUM

The Chairperson assumed there was a quorum present for each of the Companies. He noted that if the Administrators became aware of any irregularities from this assumption or if any person is aggrieved by this assumption, the Administrators will bring the matter to the attention of the Courts and seek appropriate directions or orders.

The Chairperson then declared there to be a quorum for each of the Companies pursuant to rule 75-105 of the IPR.

#### TABLING OF DOCUMENTS

The Chairperson then tabled the following documents:

- Notice of the Concurrent First Meetings of Creditors of the Companies dated 21 April 2020
- Advertisement on the ASIC Insolvency Notices website dated 21 April 2020
- Declaration of Independence, Relevant Relationships and Indemnities (**DIRRI**) dated 20 April 2020
- Copy of the Orders made in the Federal Court of Australia dated 24 April 2020.

The Chairperson advised that tabled documents would be made available on the Deloitte administration website: [www.deloitte.com/au/virgin](http://www.deloitte.com/au/virgin).

#### COURT ORDERS AFFECTING THE CONDUCT OF THE MEETING

The Chairperson discussed the Administrators' application to the Federal Court of Australia that was heard by Middleton J on Friday, 24 April 2020, and the Orders subsequently made by the Court that affect the conduct of the voluntary administration going forward.

The Chairperson advised of the notable changes to the conduct of the voluntary administration arising from the Orders, including:

1. the ability for statutory notices to creditors to be sent electronically or published on the Deloitte Virgin Australia website: [www.deloitte.com/au/virgin](http://www.deloitte.com/au/virgin)
2. the ability for meetings of creditors to be held electronically due to COVID-19 restrictions on public gatherings
3. the requirement for proxy forms for meetings of creditors to be submitted to the Administrators no later than two (2) business days prior to the respective meeting
4. in respect of a Committee of Inspection (**COI**):
  - a. a single COI is to be formed for all Virgin entities in Administration;
  - b. the members of the COI will be persons proposed by the Administrators, based on nominations received; and
  - c. creditors will have the opportunity to approve or reject the proposed COI by a vote to be held within five (5) business days of the proposed COI being sent to creditors.
5. meetings of a COI will be held electronically due to COVID-19 restrictions
6. in respect to providing information to creditors:
  - a. the Administrators will now have ten (10) business days to respond to creditors' requests pursuant to rule 70-1(2)(a) of the IPR; and
  - b. information, reports or documents may be provided in response to these requests by means of publication on the Administrators' website: [www.deloitte.com/au/virgin](http://www.deloitte.com/au/virgin)
7. orders pursuant to sections 443B of the *Corporations Act 2001 (Act)* for the personal liability of the administrators under section 443A to commence on 26 May 2020.

The Chairperson provided further explanation to the last order, noting it meant the Administrators would not be personally liable for liability arising from leased property used or occupied by the Companies until 26 May 2020. He advised this order provided the Administrators with valuable time to assess that property and to ensure that any liability assumed thereafter is a liability required during the administration process.

The Chairperson noted there will be a requirement for further applications to Court for directions or orders as the administration progresses. He advised the Administrators are expecting to make application(s) to Court seeking orders to:

1. limit the personal liability of the Administrators under certain contracts the Administrators will need to enter as part of the Voluntary Administration process
2. extend the convening period to hold the second meetings of creditors.

#### PURPOSE AND PROCESS OF VOLUNTARY ADMINISTRATION

The Chairperson provided a brief explanation of the purpose and process of voluntary administration, noting the salient purpose of a voluntary administration is to maximise the chances of a business continuing in existence or, if this is not achievable, providing for a better return to creditors.

The Chairperson advised the appointment of the Administrators was made by the directors of each of the Companies.

The Chairperson informed the meeting of the role and obligations of an Administrator enshrined in Sections 437A and 438A of the Act.

The Chairperson advised that the Administrators are required to convene a second meeting of creditors at which the future of the Companies will be resolved by creditors.

Taking into account the size and nature of the Companies' operations, the impact of the COVID-19 pandemic, and the Administrators' intentions to achieve a restructure of the Companies, it is the Administrators' intention to apply to Court for an extension of the period in which they are required to convene the second meeting of creditors for a period of up to three (3) months.

The Chairperson explained that an application to extend the convening period was a common request in voluntary administrations involving large and complex businesses, and further, the extension would allow the Administrators necessary time to undertake the restructuring of the Companies.

The Chairperson asked that any creditors who have an objection to a potential extension of the convening period raise this objection in writing and sent to the email address: [virginadmin@deloitte.com.au](mailto:virginadmin@deloitte.com.au).

It was noted by the Chairperson that without an extension of the convening period, the Administrators would be required to convene the second meeting on or prior to 22 May 2020, which is not an appropriate timeframe given the size and complexity of the Virgin Australia business and the restructuring process being undertaken.

#### DECLARATION OF INDEPENDENCE, RELEVANT RELATIONSHIPS AND INDEMNITIES (DIRRI)

The Chairperson referred to the DIRRI dated 20 April 2020 and made pursuant to Section 436DA(4) of the Act, which was provided to creditors with the Initial Notice dated 21 April 2020.

The Chairperson advised there had been no change to the Administrators' position of independence nor any amendments to the DIRRI.

#### ADMINISTRATORS' COMMENTS IN RESPECT OF VOLUNTARY ADMINISTRATION

The Chairperson then made the following comments with respect to the appointment of Voluntary Administrators to the Companies.

The COVID-19 pandemic has had a significant impact on airlines all over the globe. The necessary travel restrictions imposed by the government to limit the spread of COVID-19 has resulted in Virgin Australia grounding most of its fleet and standing down some 80% of its workforce.

This could not have come at a worse time for Virgin Australia. It had already taken proactive action to reduce its costs and implemented a business transformation plan and was preparing a restructure of its debt.

With the reduction in revenue due to reduced flights, the business simply did not have the resources to manage through this crisis. The Board and Management teams sought funding to get through this period, however this was not forthcoming, resulting in the board taking the action to appoint the Voluntary Administrators.

#### REPORT OF THE ADMINISTRATOR

The Chairperson provided the meeting with a brief overview of the corporate structure of the Virgin Group. He explained the Virgin Group could be further categorised into five (5) separate sub-groups:

1. International Flying Rights Group, being the entity that holds various rights and authorisations to permit the Virgin Group to operate international flights;
2. VAA Group, being the main operating that also employs the most staff and owns and leases property;
3. VARA Group, being Virgin Australia Regional Airlines, which is the Western Australia operating entity that charters F100 and A320 aircraft and is also an employing entity;
4. Tiger Group, which included the operating and employing entity for Tiger Airways; and
5. Leasing Group, being the aircraft lease holding entities which also operate the aircraft that are leased to the VAA Group.

The Chairperson advised the meeting that Tiger International Number1 Pty Ltd (**Tiger No1**) was placed into voluntary administration on 28 April 2020, with the same Administrators appointed to undertake the process. He noted that Tiger No1 is guarantor of unsecured notes, and accordingly, the board of Tiger No1 formed the view that Tiger No1 may be insolvent or would likely become insolvent at some future time.

The Chairperson then briefly outlined the main actions taken by the Administrators since their appointment, including:

#### *Statutory compliance*

- attending to ASIC filings and statutory tasks
- convening first meeting of creditors
- issuing notices to creditors and employees

#### *Employees*

- meetings with employees and the unions representing employees
- processing payroll
- preliminary calculation of employee entitlements
- assisting the Company to apply for and process JobKeeper payments

#### *Administration and operational issues*

- processing creditor claims and establishing a database to record creditor claims and assist ongoing management of creditor claims
- establish six (6) administration mailboxes which have received over 4,900 emails from creditors and stakeholders to date

#### *Business operations*

- majority of time to date spent gaining an understanding of the business and trading operations to ensure stability in the trading environment
- supporting the existing Virgin management team

#### *Assets*

- identifying and securing assets
- insuring assets
- reviewing and maintaining asset maintenance schedules
- identifying owners of assets and securing assets
- dealing with secured parties

#### *Restructuring and sale process*

- commencing restructure process

#### *Secured creditors*

- meetings with secured creditors
- preliminary calculation of secured debts
- negotiations with secured parties regarding continued use of secured assets

#### *Bondholders*

- meeting and liaising with bondholders to ensure that group of creditors receives adequate communications

#### *Other unsecured creditors*

- liaising with a large number of unsecured creditors regarding the Administration process
- receiving and processing Proofs of Debt and Proxy forms

#### *Shareholders*

- responding to shareholder queries regarding the Administration

#### *Government*

- liaising with Government representatives at the State and Federal level

#### *Landlords*

- negotiating with landlords regarding rent relief

#### *Stakeholders*

- liaising with all other stakeholders regarding the Administration

The Chairperson provided the meeting with the following summary of employees across the Virgin Group:

The Chairperson advised there are four employing entities in the Virgin Group employing over 9,000 employees.

#### UPDATE ON RESTRUCTURING PROCESS

The Chairperson advised the objective of the voluntary administration remains to restructure and refinance the Virgin Australia business. He confirmed the Administrators had appointed financial advisors Houllihan Lokey and Morgan Stanley to assist with the restructuring process.

The Chairperson outlined the Administrators anticipated timeline for the restructuring process:

The Chairperson advised there had been an extraordinary amount of interest from parties wanting to be a part of Virgin Australia's future. He advised that, last week, the Administrators issued a flyer to interested parties and set the recapitalisation timetable. This week, the Administrators have issued an Information Memorandum and opened the data room.

The Chairperson advised the Administrators have no doubt the restructure process will be very competitive, and they expect bids from high quality bidders. He commented that the early level of interest speaks to the strength of the airline in Australia, its loyal customer base and the exceptional team of people it employs.

The Chairperson advised the Administrators will manage the restructure process in a very fair, disciplined way. He appreciated the restructure process may become political with so much interest and – given Virgin's standing in Australia – come with a high degree of media interest and scrutiny. He advised it was the Administrators' intention to bring the sale process to a conclusion quickly, fairly and in the best interests of Virgin Group's creditors and the Companies' future.

The Chairperson noted the Administrators' remained acutely aware of the people who work for the airline and the impact this process has on them. The Chairperson advised that he and Paul Scurrah spoke with employees again that morning to give them an update and they will be speaking to them again that afternoon and throughout the coming weeks.

The Chairperson reiterated comments he made publicly the prior week that there are no changes to their employment and wages will continue to be paid, including the Job Keeper allowance to staff who have been stood down and are eligible.

The Chairperson advised the business continues to operate and play an important role in the Australian economy. He advised the airline is currently running 64 return domestic services each week with the support of the Australian government, which is helping to keep freight corridors open and help maintain links between local cities. Internationally, the airline continues to operate repatriation flights from Hong Kong and Los Angeles, which are also helping to bring important freight and medical supplies into the country and support Australia's exports: The Chairperson commented that government has been clear that two domestic airlines are needed in Australia. He further commented that Virgin had spent many years building itself into a strong competitor to Qantas and noted the benefit that had brought to Australian aviation over that period.

The Chairperson advised that the Administrators' discussions with government will remain important in the coming weeks and noted the state and federal governments' various public statements in recent days. Key to those discussions will be the important contribution Virgin Australia makes at a state and national level; not only through jobs, but also through competitive domestic airline services, connections to overseas destinations and helping to support passenger growth in regions and regional tourism sectors. He commented that Australia is a strong aviation market - with some of the busiest air routes in the world and long periods of steady passenger growth.

The Chairperson reiterated that the Administrators want to ensure the recapitalisation process is successful and Virgin Australia comes out of voluntary administration as soon as possible.

#### QUESTIONS BY THE CREDITORS

The Chairperson first addressed some of the questions submitted by creditors prior to the meeting.

#### **With most staff stood down how will surplus staff be managed by the Administrators?**

The Chairperson advised that those staff stood down prior to the voluntary administration would remain stood down at this time. He advised they are continuing to monitor staffing requirements throughout the period of travel restrictions, however, there were no plans for any redundancies as we position the business for relaunch and sale.



**Is it possible for the Administrators to renegotiate Enterprise Agreements, and if so, is this currently being considered?**

The Chairperson advised the Administrators have no plans to renegotiate Enterprise Agreements.

**How does the stand down affect my employee entitlements – will these continue to accrue?**

In response, the Chairperson advised the entitlements of stood down staff would be preserved and will continue to accrue during the administration period.

**What is the level of secured debt?**

The Chairperson advised the Administrators are working with secured creditors to accurately verify their current claims. He noted that the Administrators will report on secured debt in more detail in the Administrators' second report to creditors.

The Chairperson noted that there had been numerous questions received prior to the meeting regarding outstanding invoices and pre-appointment debts owed to suppliers and trade creditors. The Chairperson noted that these queries are answered in the creditor and supplier FAQs which are available on the Deloitte Virgin Administration website.

**What role does the Virgin Board and State and Federal Governments have in the restructuring process, and whether they had any influence in determining the successful purchaser?**

The Chairperson advised that the Virgin Board's powers were suspended upon the commencement of the voluntary administrators, and those powers are now assumed by the Administrators. The Chairperson also confirmed the Administrators are working with the Government daily to explore all options for restructuring the business. He noted that while the Board and Government have a view around the future of Virgin, the Administrators are bound by their statutory duties to act in the interest of all creditors.

**Why were Clayton Utz and Morgan Stanley engaged, and what roles do they play?**

The Chairperson noted Clayton Utz had been advising the Companies prior to the voluntary administrations, and their engagement has been continued by the Administrators. This is due to their significant prior knowledge and experience around the business and its structure, which enables the Administrators to deal with issues quickly and as they arise. The Chairperson noted this is a common practice on large insolvency matters, and advised that if a conflict arises, the Administrators will seek independent legal counsel on those matters.

The Chairperson advised Morgan Stanley had been engaged to work jointly with Houlihan Lokey on the restructuring process. He noted that Morgan Stanley had too been engaged by the Companies prior to administration and have been engaged by the Administrators given their prior knowledge and experience of the Companies and the Virgin business.

**How will the Administration impact bondholders? What will happen to the value of these bonds and will coupons continue to be paid on schedule until maturity?**

The Chairperson noted that all bonds are an unsecured debt of the Companies, and the claims of bondholders will therefore rank equally with other unsecured creditors. He noted the value will be dependent on the outcome of the restructuring process and the ultimate return to creditors. The Chairperson advised coupon payment would not be made.

Questions submitted by creditors during the meeting were then put to the Chairperson by Mr David Orr.

Mr Orr, on behalf of a creditor, asked whether a commitment on job security could be provided to employees, and what steps the Administrators were taking to ensure employees had a future with a restructured Virgin Australia?

The Chairperson reiterated that there is no plan for redundancies. He noted the continuing employment structure will be subject to negotiations with the ultimate interested party, however, the Administrators will carefully consider implications on employees when reviewing and assessing offers.

Mr Orr, on behalf of a creditor, asked what the Administrators were doing to ensure that a new buyer continues to provide a sustainable and successful second national airline?

In response, the Chairperson advised the purpose of the restructuring process was to avoid breaking up and selling parts of the business. He reiterated that the best outcome for everyone is the preservation of the whole business. While the process currently being undertaken by the Administrators is to create optionality for an incoming purchaser, offers will be assessed with the impact on all creditors in mind.

Mr Orr, on behalf of a creditor, asked the Chairperson to outline the level of support the Federal Government has indicated they are prepared to provide?

The Chairperson noted discussions with the Federal Government and their appointed advisor were ongoing and advised that he is unable to comment further at this stage.

Mr Orr, on behalf of a creditor, asked if the Chairperson could confirm that all employee entitlements would be covered?

The Chairperson advised that the initial assessment was that there will be sufficient assets to cover employee entitlements. He also noted that, if there are insufficient assets and the employing entities be placed into liquidation, employees will have access to the Federal Government's Fair Entitlement Guarantee scheme.

Mr Orr, on behalf of a creditor, queried why are the Velocity entities not in voluntary administration?

The Chairperson noted that, while owned by the Virgin Group, the Velocity entities operate as a separate legal structure.

Mr Orr, on behalf of a creditor, asked if it was the Administrators intention to fly normal routes again when COVID-19 restrictions end?

The Chairperson indicated it was difficult to plan future operations given uncertainty on restrictions, however, the Administrators are regularly discussing future operations with Virgin management.

Mr Orr, on behalf of a creditor, asked about payment for goods and services supplied to the Companies during the administration?

The Chairperson confirmed that payment would be made for services required by the Administrators.

Mr Orr, on behalf of a creditor, asked when the report to creditors would be available?

The Chairperson advised the Administrators' report to creditors will be issued around one week prior to the second meeting of creditors.

Mr Orr, on behalf of a creditor, asked if customers' travel bank credits will be honoured?

The Chairperson advised that travel bank credits remain valid and the intention is to honour these in the future.

Mr Orr, on behalf of a creditor, enquired as to the role of Akin Gump?

The Chairperson remarked that Akin Gump is a US based law firm who have been engaged by the Administrators to assist with US bondholder relations as well as having the voluntary administration processed recognised in the US Bankruptcy Court.

#### COMMITTEE OF INSPECTION

Pursuant to the Orders of the Federal Court of the Australia made on 24 April 2020, the Administrators are to propose a Committee of Inspection to creditors for their consideration.

The functions of a committee of inspection is:

1. to consult with the administrator about matters relating to the administration; and
2. to receive and consider reports by the administrators.

A COI can:

- Approve remuneration of the external administrator
- Require the administrator to convene a meeting of creditors
- Request information from the external administrator]

He noted the proposed committee of inspection will be established having regard to:

- representation of all classes and types of creditors, be that employees, trade creditors, secured creditors, bondholders, financiers or lessors;
- the size of the debt owed to the respective nominees;
- the number of nominations received in respect to each of these different classes of creditors; and
- the relevant experience of the nominees.

The Chairperson advised the meeting that the Administrators had received 69 nominations for the committee of inspection prior to the meeting. He further advised that a circular will be issued to creditors in the coming days setting out the Administrators' proposed committee of inspection and the process for creditors to vote on whether to approve or reject the proposed committee.

The meeting was then opened for final questions.

Mr Orr, on behalf of a creditor, asked whether creditors could still submit nominations for the committee of inspection?

The Chairperson advised that nominations were required to be submitted prior to the meeting, and nominations received after the meeting would not be considered.

The Chairperson noted that any further unanswered questions will be attended to after this meeting.

CLOSURE OF MEETING

The Chairperson thanked those present for attending and declared the meeting closed at 12:06PM.
