Orders sought

1. That the Receivers would be justified in realising, by sale, the jewellery identified in Schedule 1A to this application and applying the proceeds of such sale:
 - (i) first, in discharge of the costs of the sale process; and
 - (ii) thereafter by deposit into the Receivers' Trust account established in accordance with paragraph 4(d) of the orders made by the Court on 22 November 2021.
2. That the Receivers would be justified in taking possession of items of jewellery identified in Schedule 1B to this application from Canturi Corporation Pty Ltd.
3. That the Receivers would be justified in realising, by sale, the jewellery identified in Schedule 1B to this application and applying the proceeds of such sale:
 - (i) first, in discharge of the costs of the sale process; and
 - (ii) thereafter by deposit into the Receivers' Trust account established in accordance with paragraph 4(d) of the orders made by the Court on 22 November 2021.
4. That the Receivers would be justified in realising, by sale, the jewellery identified in Schedule 1C to this application and applying the proceeds of such sale:
 - (i) first, in discharge of the costs of the sale process; and
 - (ii) thereafter by deposit into the Receivers' Trust account established in accordance with paragraph 4(d) of the orders made by the Court on 22 November 2021.

- a. first, in discharge of the costs of the sale process; and

20. Alternatively, to Order 19, an Order that within fourteen (14) days Adam Grimley and Anthony Koletti file and serve any evidence upon which they rely in opposing the Orders sought in this application.
21. An order pursuant to section 37AF(1) of the Federal Court of Australia Act 1976 (Cth) that, until further order, the publication or disclosure of the three affidavits of Michael Kevin Hayter sworn 17 February 2022 and filed in support of the amended interlocutory application of Bruce Gleeson and Daniel Robert Soire in their capacity as receivers of the property of Melissa Louise Caddick, insofar as they refer to the name of the son of the first defendant and the address of the Property situated at Edgecliff and included in the definition of Real Property in the third further amended originating process filed by the Australian Securities and Investment Commission on 22 November 2021, is prohibited other than to the parties to this proceeding and each of their legal representatives.
