### **THE COURT ORDERS BY CONSENT THAT:**

#### **Discovery**

1. By 4.30 pm (AEDT) on 4 November 2024, each party provide to the other party a list of categories of documents that it seeks the other party discover.
2. By 4.30 pm (AEDT) on 8 November 2024, each party notify the other party of which, if any, categories of documents referred to in Order 1 it agrees to discover.
3. By 4.30 pm (AEDT) on 15 November 2024, any party seeking a discovery order file an application for discovery.

#### **Statement of Agreed Facts**

4. On or before 6 December 2024, the applicant provide the respondent with a proposed statement of agreed facts.
5. On or before 13 December 2024, the respondent provide the applicant with its response to the applicant's proposed agreed statement of facts.
6. On or before 20 December 2024, the applicant file and serve the agreed statement of facts.

#### **Outline of Submissions**

7. On or before 13 January 2025, the applicant file and serve an outline of opening submissions.



8. On or before 20 January 2025, the respondent file and serve an outline of opening submissions.
9. On or before 28 January 2025, the applicant file and serve an outline of submissions in reply.

#### **Court Book**

10. On or before 13 January 2025, the applicant provide the respondent with a draft index of the documents which the applicant proposes to include in the court book.
11. On or before 17 January 2025, the respondent provide the applicant with an amended draft index identifying any additional documents it proposes to include in the court book.
12. On or before 29 January 2025, the applicant provide to the Court's registry an electronic copy of the court book in accordance with Format 1 and the general requirements of the eBooks practice note (GPN-eBooks).

#### **Objections to evidence**

13. On or before 20 January 2025, the parties exchange a list of objections to evidence.
14. Counsel for the parties are to confer in relation to their respective objections to evidence, with a view to resolving the issues in dispute.
15. On or before 29 January 2025, the parties provide the Court with a list of outstanding objections to evidence.

#### **Trial Schedule**

16. On or before 29 January 2025, the parties confer and provide the Court with an agreed hearing schedule.

#### **Liberty to apply**

17. The parties have liberty to apply
