I, Ita Buttrose, at Sydney, New South Wales, say on oath:

 I was the Chair of the Board of the Australian Broadcasting Corporation (ABC) between February 2019 and March 2024.

- 2. I make this statement based on my own direct observations and knowledge, save for where I say otherwise. Where I depose to matters based on information provided to me,
- 3. I identify the source of that information and otherwise believe such information to be true and correct, based on the source of the information, the source's role and the circumstances in which it was provided to me.
- 4. Where I state words that I have spoken or heard, I will do so setting out the substance or gist of those words to the best of my recollection.
- 5. Exhibited and marked "**IB-01**" is a bundle of email correspondence. In making this affidavit, I have in front of me and have had regard to **Exhibit IB-01**.

#### MY ROLE AS THE CHAIR OF THE ABC

- 6. While I was the Chair, the ABC provided me with an email address, <a href="mailto:buttrose.ita@abc.net.au">buttrose.ita@abc.net.au</a> (personal email address). I also had direct access to the email address <a href="mailto:board@abc.net.au">board@abc.net.au</a> (Board email address).
- 7. As part of my role as Chair, my practice was to monitor emails that were sent to both the personal and Board email addresses, and either respond to them myself, or arrange for a response to be sent by my Executive Assistant or one of the ABC's staff. My Executive Assistant, Lauren Stokes, also had access to the Board email address, and brought emails to my attention at her discretion.
- 8. I am aware that the duties of the members of the Board of the ABC are set out in the *Australian Broadcasting Corporation Act 1983* (**ABC Act**). They include the maintenance of the ABC's independence and integrity, and ensuring that the ABC's presentation of news and information was impartial. As Chair, I considered that impartiality was central to the ABC's statutory responsibilities, and that because of that it was essential that staff who presented programmes that were broadcast by the ABC did not engage in conduct that could reasonably be seen not to be impartial.
- 9. In my role as Chair, I was responsible for presiding over meetings of the Board, was a link between the Board and the Managing Director, David Anderson, and offered general guidance and counsel to Mr Anderson at the level of policy and strategic direction. It was not my role to be involved in the day-to-day operation of the ABC, and I did not do so.

Operational matters were the exclusive responsibility of Mr Anderson and the staff reporting to him.

#### **MS ANTOINETTE LATTOUF**

- 10. To my recollection, I have never met Ms Antoinette Lattouf.
- 11. Before 18 December 2023, I had not heard of Ms Lattouf, and did not know anything about her.
- I was not involved in the making any decisions to hire Ms Lattouf to present on ABC Radio.
- 13. The first time I became aware of Ms Lattouf was on 18 December 2023.

# **MONDAY, 18 DECEMBER 2023**

- 14. On Monday, 18 December 2023, I noticed a high volume of emails making complaints in relation to Ms Lattouf.
- 15. From the emails I gathered that Ms Lattouf had recently begun to present a show on ABC Radio. The general impression I got from the emails I read was of complaints that Ms Lattouf should not have been hired by the ABC as a presenter because she was a pro-Palestinian activist who had made provocative statements about the Israel-Gaza conflict. The substance of the complaints, as I understood them at the time, was that her activities outside the ABC meant that she was perceived by complainants not to be impartial.
- 16. I did not recognise or know of any of the names of the persons from whom I received complaint emails, although, from their names, I assumed that many of them were of a Jewish background. I was not concerned about the background of the complainants other than that they appeared to listen to ABC Radio.
- 17. I did not look at Ms Lattouf's social media and, at the time of making this affidavit, I still have not done so.
- 18. From the time when I first became aware of complaints about Ms Lattouf, and throughout the whole period of the events that are the subject of this affidavit:

La Quine alvilson.

- (a) I was concerned that it appeared, based on the complaints, a significant number of ABC listeners were unhappy that the ABC had hired someone as a presenter who they perceived to be not impartial. I was concerned at the damage Ms Lattouf's appointment was doing to the ABC's and ABC Radio Sydney's reputation for impartiality. This issue was a significant concern for me;
- (b) The issue for me was not whether Ms Lattouf was pro-Palestinian or pro-Israeli. Rather, the issue was that Ms Lattouf appeared to be an activist in relation to the Israel-Gaza conflict, which was a serious and contentious matter of concern in the community, regardless of which side of that conflict she was an activist for. I do not support the hiring of activists of any cause to the ABC;
- (c) I had no knowledge of Ms Lattouf's race or national extraction. I am informed that it is said that Ms Lattouf has a Lebanese and/or Arab and/or Middle Eastern heritage, and that she is a descendant of foreign immigrants. This was, and is, irrelevant to me.

# **TUESDAY, 19 DECEMBER 2023**

- 19. On the morning of Tuesday, 19 December 2023, I met with Mr Anderson, in person, in my office at the ABC for one of our regular one-on-one meetings on Tuesday each week.
- 20. I prepared the agenda for our meeting on Tuesday, 19 December 2023, which included the following listed as a topic for discussion:

Antoinette Lattouf Complaints

27 emails and counting.

3 email examples attached.

A redacted copy of the agenda for my meeting with Mr Anderson on Tuesday, 19
December 2023, and three emails that were attached, is in **Exhibit IB-01** at **Tab 1**.
Those portions of the agenda that do not concern Ms Lattouf have been redacted so as to preserve the confidentiality of their subject matters.

- 21. During my meeting with Mr Anderson on Tuesday, 19 December 2023, we had the following conversation:
  - (a) I asked Mr Anderson: 'What is going on? We have all of these complaints coming in about Antoinette Lattouf. What are we doing about it?'
  - (b) Mr Anderson said something that indicated to me Ms Lattouf had been hired as a casual employee for five days as a holiday relief.
  - (c) Mr Anderson also said something that gave me the impression that he thought there was an issue about whether Ms Lattouf had been hired without proper checks having been made of her activities and references. This was a matter of significant concern to me.
  - (d) Mr Anderson told me to forward the complaints that I had received about Ms Lattouf to Mr Chris Oliver-Taylor, ABC Chief Content Officer. This was a departure from my usual practice in relation to complaints, which was to send them to Mr Anderson. My understanding was that Mr Oliver-Taylor had been given the task of officially responding to complaints about Ms Lattouf.
- 22. On Tuesday, 19 December 2023, at some time after my meeting with Mr Anderson, I told my Executive Assistant, Ms Stokes, that Mr Oliver-Taylor would be officially responding to complainants about Ms Lattouf, and that all such complaints should be forwarded to him. My reason for giving this instruction was to give effect to the arrangement described in subparagraph [21(d)].
- 23. I am aware that at 3.28 pm on Tuesday, 19 December 2023, Ms Stokes sent an email to Mr Oliver-Taylor attaching 29 emails containing complaints received by the ABC regarding Ms Lattouf. A copy of that email has been provided to me and is in **Exhibit IB-01** at **Tab 2**.
- 24. I did not ask Mr Oliver-Taylor to do anything in particular to resolve the complaints. It is not my role as Chair to tell staff what to do. I assumed that Mr Oliver-Taylor would deal with the complaints.
- 25. At 8.49 pm on Tuesday, 19 December 2023, I forwarded one of the complaints to Mr Anderson by email. I did not know the person who apparently sent the complaint, and

chose his email at random, because it was recent in my inbox. In my email to Mr Anderson I wrote:

Has Antoinette been replaced. I am over getting emails about her. Regards Ita.

- 26. As at the time when I wrote and sent this email, I had never discussed with Mr Anderson anything to do with replacing Ms Lattouf, and he had never said anything to me that suggested she would or might be replaced. I was conscious of the number of complaints about Ms Lattouf. The reason why I asked '[h]as Antoinette been replaced' was that I wanted to know whether the situation that was generating the complaints had come to end.
- 27. At 9.26 pm on Tuesday, 19 December 2023, I received an email from Mr Anderson in response to the email I had sent at 8.49 pm. Mr Anderson wrote:

Dear Ita.

Antoinette will finish up on Friday. It's a managed exit given the situation. I can explain more tomorrow.

I plan to respond to all those that have emailed on Friday afternoon.

Regards, David

- 28. From Mr Anderson's email I understood that he, and the responsible staff, had decided that Ms Lattouf would continue to present until the end of the week.
- 29. I accepted that Mr Anderson and his staff had the exclusive responsibility for making and implementing this decision. However, I wanted to challenge that decision.
- 30. Accordingly, at 9.59 pm on Tuesday, 19 December 2023, I sent an email to Mr Anderson in response to his email at 9.26 pm, writing:

I have a whole clutch more of complaints. Why can't she come down with flu? Or Covid. Or a stomach upset? We owe her nothing, we are copping criticism because she wasn't honest when she was appointed.

Managed exit. Really.

Sant. Gluth I don't like emailing you late but I am wrapping present.

We should be in damage control not managed exits David.

31. My reasons for writing and sending the emails referred to in paragraphs [25] and [30] were the concerns that I have described in sub-paragraphs [18(a)] and [Error! Reference source not found.]. I also had in mind the concern that I have identified in subparagraph [21(c)].

#### WEDNESDAY, 20 DECEMBER 2023

32. At 10.57 am on Wednesday, 20 December 2023, I received an email from Mr Anderson. He wrote:

Dear Ita,

We are absolutely in damage control.

Local Radio management, specifically Steve Ahern, has put us in an unacceptable position. Mr Ahern made a negligent, error of judgement by employing Ms Lattouf without assessing her prior media and social media activity. I am taking action through Chris Oliver-Taylor alleging serious misconduct resulting in reputational damage to the ABC as a result of his actions.

We have weighed up the consequences of prematurely pulling Antoinette Lattouf off air, versus managing this until Friday as per her contract. We have concluded that the best possible outcome from here is to manage this such that Ms Lattouf does not editorial engage in the Middle East conflict while on air for the remainder of her contract.

This protects the ABC (and out staff) from the consequence of removing her, without her having breached any of our standards this week, when her position on the matter was known by Mr Ahern when Ms Lattouf was engaged. If we do remove her, there will be claims of doing so without cause given her position on the Middle East was widely known prior to her engagement, we have caved to pro-Israeli lobbying, and she hasn't actually breached impartiality this week.

Again, we have been placed in an untenable position.

alvilson.

We have directed Ms Lattouf and the produces that the topic of the Middle East conflict is off limits, there is a lengthy off-air delay in place, and we will use the dump button if that direction is disobeyed. We have also instructed producers not to allow callers through who wish to discuss that topic. To date, that direction has been followed.

There is without doubt already damage caused by her engagement. I expect the WhatsApp group email campaign where we are receiving emails regarding her 'appointment' to continue until we reveal on Friday that Ms Lattouf will not be returning next week.

In addition, we have a protest today outside of our Melbourne offices, from pro-Palestinian protesters, against the ABC. Staff are using separate entrance / exits and security is on site.

I will see you soon to discuss any further queries you may have.

- 33. I immediately read and considered Mr Anderson's email. From it, I understood that, notwithstanding anything that I had said in the email referred to in paragraph [30], Mr Anderson and the responsible staff continued to have the position that Ms Lattouf would continue to present until the end of the week. I accepted that to be the final decision on the matter.
- 34. Accordingly, at 11.00 am on Wednesday, 20 December 2023, I responded to Mr Anderson by email, writing:

Thanks for the explanation, David – it must be Christmas.

See you at lunch.

35. A copy of the email chain containing emails referred to at paragraphs [25], [27], [30], [32] and [34] is in **Exhibit IB-01** at **Tab 3**. When searching my email inbox before I left the ABC, I could not locate a copy of the email referred to at paragraph [34] above, but I have since been provided with a copy by the ABC and I recall writing that email.

36. Once I understood the position to be that described in paragraph [32], I took the steps that I will describe in paragraphs [37] and [38] below.

37. Between 11.04 am and 11.31 am on Wednesday, 20 December 2023, I responded to 26 emails containing from members of the public with a standard response email, customising the person's name. In each of those responses I wrote:

Dear [name]

Thank you for your email. The contents have been noted.

I have forwarded your email on to Chris Oliver-Taylor, the ABC's Chief Content Officer, who is dealing with this matter.

Sincerely

Ita Buttrose

Chair - ABC

- 38. Between 11.13 am and 11.32 am on Wednesday, 20 December 2023, I sent multiple emails to Mr Oliver-Taylor providing copies of emails that I had sent in response to complaints received by the ABC in relation to Ms Lattouf being on ABC Radio Sydney. In that regard:
  - (a) at 11.13 am, I sent an email with subject line 'More complaints Antoinette 702' and there was no content in the body of the email. My email attached 12 emails that I had sent in response to complaints from members of the public about Ms Lattouf (a copy of that email is in Exhibit IB-01 at Tab 4);
  - (b) at 11.15 am Mr Oliver-Taylor responded (a copy of that email is in Exhibit IB-01 at Tab 5);
  - (c) at 11.19 am I sent a second email to Mr Oliver-Taylor, attaching another 5 emails that I had sent in response to complaints from members of the public about Ms Lattouf. There was no content in the body of the email (a copy of that email is in **Exhibit IB-01** at **Tab 6**);
  - (d) at 11.24 am I sent a third email to Mr Oliver-Taylor with subject line 'The complaints keep coming Antoinette 702', attaching another 3 emails that I had

sent in response to complaints from members of the public about Ms Lattouf.

There was no content in the body of the email (a copy of that email is in **Exhibit IB-01** at **Tab 7**);

- (e) at 11.24 am Mr Oliver-Taylor responded (a copy of that email is in Exhibit IB-01 at Tab 8);
- (f) at 11.25 am I responded to Mr Oliver-Taylor, writing 'It goes with the job Chris...I think we will keep getting these complaints until Antoinette leaves' (a copy of that email is in **Exhibit IB-01** at **Tab 9**);
- (g) at 11.26 am Mr Oliver-Taylor responded (a copy of that email is in **Exhibit IB-01** at **Tab 10**);
- (h) at 11.27 am I forwarded one further complaint email to Mr Oliver-Taylor. I wrote 'I think I didn't include in the earlier emails Chris. Ita' (a copy of that email is in **Exhibit IB-01** at **Tab 11**). I do not know the person who apparently sent the email. The reason I sent this email to Mr Oliver-Taylor separately was because I noticed it had not been included in the previous emails I had sent to Mr Oliver-Taylor; and
- (i) at 11.32 am I sent to Mr Oliver-Taylor two more response emails with subject line 'This is the lot for now Chris...Ita' (a copy of that email is in **Exhibit IB-01** at **Tab** 12).
- 39. The reason I sent the emails referred to in paragraph [38] was to give effect to the arrangement referred to in subparagraph [21(d)] and so that he knew that a preliminary response email had been sent to those persons.
- 40. From approximately 12.30 pm to 2.30 pm on Wednesday, 20 December 2023, I went to lunch with Mr Anderson at a restaurant called "Luke's Kitchen" in Pitt Street, Sydney. The lunch had been arranged some time earlier, as our annual Christmas lunch. When I left for lunch, I understood that the final decision of Mr Anderson and the responsible staff was that Ms Lattouf would be finishing her work with the ABC on Friday 22 December 2023.
- 41. I do not now recall the discussions that Mr Anderson and I had during the course of lunch on 20 December 2024. I do not recall whether we discussed Ms Lattouf.

- 42. My recollection is that after we had finished lunch, a driver picked up Mr Anderson and me from the restaurant to take Mr Anderson back to the ABC office building and then take me home. During the drive back from lunch, Mr Anderson told me that Mr Oliver-Taylor had told him that he had decided that Ms Lattouf was going to be taken off air and would not continue as an ABC broadcaster because she had disobeyed a direction not to post on social media. I understood this to mean that Ms Lattouf was finishing up that day and wasn't coming back.
- 43. I had not seen any social media posts made by Ms Lattouf. I did not directly, nor did I ask anyone to on my behalf, make enquiries about what Ms Lattouf had posted on social media that had caused Mr Oliver-Taylor to decide to take her off air. I did not have any discussions with Mr Oliver-Taylor about the decision he made. These are operational matters.
- 44. I am aware that in the early afternoon of Wednesday, 20 December 2023, an article was published online in *The Australian* newspaper, authored by Ms Sophie Elsworth. That article said '*The Australian understands that the complaints over Lattouf's appointment were raised with Ms Buttrose and the board, with sources close to ABC management saying that chairwoman was "furious" with the decision to hire the anti-Israel broadcaster'. In relation to that article and its contents:* 
  - (a) I read this article shortly after it was published, but I cannot recall exactly when I did so;
  - (b) I did not speak to or have any communication with Ms Elsworth before or after the publication of the article;
  - (c) I do not have any knowledge of who (if anyone) Ms Elsworth was quoting as "sources close to ABC management"; and
  - (d) I was not "furious" with the decision to hire Ms Lattouf, did not tell anyone that I was so, and have no knowledge of the basis on which Ms Elsworth made that claim.
- 45. At some time during the afternoon of Wednesday, 20 December 2023, I asked Mr Nick Leys (who is the ABC Director of Communications) if there was an ABC media release or statement regarding Ms Lattouf, for the purpose of checking the terminology used by



the ABC, so that I could be consistent in my responses to members of the public if the matter was raised with me.

46. At 5.27 pm on Wednesday, 20 December 2023, I received an email from Mr Leys in which he provided me with the phrase 'ABC Sydney casual presenter Antoinette Lattouf will not be back on air for her remaining two shifts this week'. A copy of that email is in **Exhibit IB-01** at **Tab 13**.

47. Between 5.33 pm and 5.46 pm on Wednesday, 20 December 2023, I responded to 9 emails from members of the public who had written to me about Ms Lattouf with a standard response email, customising the person's name. In each of those responses I wrote:

Dear [name]

You are probably unaware that Ms Lattouf no longer works at the ABC.

An ABC spokesperson released the following statement earlier today.

"ABC Sydney casual presenter Antoinette Lattouf will not be back on air for her remaining two shifts this week"

- 48. I sent the emails referred to in the previous paragraph as a matter of courtesy.
- 49. At 5.48 pm on Wednesday, 20 December 2023, I sent an email to Mr Oliver-Taylor with subject line 'these people have been advised Antoinette no longer works at the ABC Chris. Ita' and attaching nine emails that I had sent to members of the public in response to complaints made to the ABC regarding Ms Lattouf. A copy of that email is in **Exhibit IB-01** at **Tab 14**.
- At 5.51 pm on Wednesday 20 December 2023, Mr Oliver-Taylor responded to my email.

  A copy of that email is in **Exhibit IB-01** at **Tab 15**.

#### **MY REASONS**

- 51. In paragraphs [22], [26], [31], and [39] I have set out the reasons for actions that I took in relation to Ms Lattouf. I had no other reasons than what I have there stated.
- 52. I did not consider, or in any way take into account, anything that I knew about the fact or content of any political opinions that Ms Lattouf had or may have had, or her race or national extraction (including that Ms Lattouf has a Lebanese and/or Arab and/or Middle Eastern heritage and that she is a descendant of foreign immigrants). None of those matters were reasons for any correspondence that I engaged in, in relation to Ms Lattouf.

The ABC has a statutory duty to ensure that the gathering and presentation of news and information is impartial according to the recognised standards of objective journalism.

ABC Editorial Policy Standard 4.1 notes that there is a requirement to "Gather and present news and information with due impartiality."

There have now been 4 statutory declarations by independent witnesses (some of whom are not part of the Jewish community) attesting to these chants being heard at the Opera House.



As outlined above, the ABC's Editorial Standards require impartiality. A broadcaster operating under statute with public funds is legitimately expected to contribute in ways that may differ from commercial media, which are free to be partial to private interests.

Ms Lattouf is clearly not impartial on Israel. The ABC is in breach of its own policies by allowing her to continue to report on the Israel-Gaza conflict.

Dear Board-members,

I am writing to you regarding the ABC's, the national broadcaster's, choice of acting morning radio show host on ABC 702 Sydney.

I am a taxpayer and regular audience member of this program and am well versed in how popular this show is, normally hosted by Sarah Macdonald and what a widespread audience it has.

Given the very difficult times we are experiencing currently due to the Israeli - Gaza war, and the various sensitivities held by both the Israeli/Jewish and Palestinian/Arab communities it would seem Ms Lattouff was not the best selection as the summer host.

I am talking specifically about her remarks on social media regarding the Opera House debacle on October 9th, a worldwide renowned event which has cast a very negative light on our city and country. Ms Lattouff in her widely broadcasted comments has suggested that there was some questionable accounts of the hate-speech calls 'fuck the Jews' and 'gas the Jews' and had not been verified.

I personally am affronted by her tasteless comments and subsequently the ABC's choice of summer host.

I have suffered a family loss in the war which resulted in me attending the Opera House that night, specifically to see the Israeli flag projected on the Opera House as a sign of solidarity and well before the war erupted. Such projections were staged publicly in many, many cities around the world including Melbourne, Canberra and Brisbane.

The projection was cancelled at the scheduled time due to the unruly and increasingly violent behaviour of the Palestinian crowd and their supporters.

I personally found this event absolutely petrifying. Despite the very large police presence I did not feel confident that my safety would be assured.

My request from one of the policeman to move to a safer spot was met with an abrasive and negative response. I left straight away.

I have found Ms Lattouff's anti-Jewish and Israelophobic attitude to the occurrence of events on October 9th abhorrent.

Her insulting words and insinuations are not only immensely triggering but bring into question my right as a Jewish Israeli Australian to enjoy public events in safe space.







I am writing to express my grave concern that this individual is hosting ABC Sydney mornings, given her clearly biased, denialist views of what was said in Sydney within hours of the Hamas pogrom being committed in southern Israel. The role of an ABC host, who leads requires a basic level of impartiality and adherence to the ABC codes. Ms. Latouff's actions, as outlined above, call into question her ability to meet these standards.

As a taxpayer-funded public broadcasting company, the ABC has a responsibility to maintain the highest standards of journalism. The current situation, with Ms. Latouff continuing to host prime time TV, constitutes a clear breach of this obligation.

I am writing to express deep concern regarding the impartiality and adherence to the ABC code of practice by Ms. Latouff, the current host of the ABC Sydney Morning show.

Many recent actions and social media posts by Ms. Latouff are black and white evidence of her ilack of mpartiality (I would go so far as to say her extremist views) in relation to the current Middle East conflict, as well as the ongoing issues of deep and proven anti-semitism within the Australian community, which is a requirement of Clause 4 of the ABC code of practice. I would like to highlight the following issues:

Ms. Latouff co-authored an article titled "Viral footage showed protesters chanting 'Gas the Jews'. Nobody can verify it" (Crikey, Dec 13 2023), which she also shared on her social media platforms and has been widely circulated. This article unfairly questions the validity of the antisemitic rhetoric, such as "Gas the Jews" and "Fuck the Jews," witnessed at the Opera House on October 8. The intent behind the article seems to be providing a false and biased narrative based on Ms. Latouff's personal views on the war and particularly Jewish people. Unfortunately, this contributes to the alarming surge of antisemitism, which has increased by over 700% since October 7. There is clear video evidence (which has aired on Sky News and has been widely circulated elsewhere, as well as eyewitness evidence (now attested to via statutory declarations, of these chants.

Ms Lattouff has posted disgusting and unsupported posts on her social media account, including one accusing the IDF of using rape as a tool of war and having done so for 70 years. A recent instagram post of hers cited the IDF as having used rape as a tool of war since Israel was created to argue that discussing Hamas' mass rapes on 7 October (which she scknowledges took place) out of context is dangerous. This is absolutely appalling, inferring that Hamas was somehow justified in committing those atrocities as some sort of "payback".

Ms. Latouff's endorsement of the MEAA Open Letter if further evidence of her lack of impartiality when reporting on conflicts.

The role of an ABC host, who leads and provides commentary on news stories, requires a fundamental level of impartiality and adherence to the ABC codes. Ms. Latouff's aforementioned actions raise doubts about her ability to meet these standards.

In addition, she is utilising her position as a public figure, gained by virtue of her role as an ABC journalist, to foment hatred and denialism amongst the broad Australian community who listen to the ABC and assume its journalists present a balanced view.

As a publicly-funded broadcasting company, the ABC has a crucial responsibility to uphold the highest standards of journalism. The current situation, with Ms. Latouff continuing to host prime time TV, clearly violates this obligation.

I urgently request a detailed explanation of the steps the ABC intends to take to address this situation and restore the credibility of its reporting. Australians deserve accurate and unbiased information, and it is essential that swift and decisive action is taken to tackle this matter.

I anticipate your prompt attention to this issue and a thorough investigation into the concerning conduct of Ms. Latouff. In a time when journalism needs to be strong, it is imperative that the ABC remains committed to upholding journalistic integrity.



> It has come to my attention that Ms. Latouff's recent actions have raised serious questions about her impartiality, as outlined in Clause 4 of the ABC code of practice. I would like to highlight the following issues:

> Ms. Latouff co-authored an article titled "Viral footage showed protesters chanting 'Gas the Jews'. Nobody can verify it" (Crikey, Dec 13 2023), which also featured on her socials and has been widely shared. The article casts unreasonable doubt on the validity of antisemitic rhetoric, "Gas the Jews", "Fuck the Jews" witnessed at the Opera House on October 8. The intent behind the article was to provide a false and skewed narrative according to Ms. Latouff's personal views on the War and particularly Jewish people, contributing to the alarming rise in antisemitism, which has surged by over 700% since October 7.

- > Ms. Latouff's endorsement of the MEAA Open Letter raises concerns about her impartiality in reporting on conflicts.
- > The role of an ABC host, who leads and adds commentary to news stories, demands a basic level of impartiality and adherence to the ABC codes. Ms. Latouff's actions, as outlined above, call into question her ability to meet these standards.
- > As a taxpayer-funded public broadcasting company, the ABC has a vital responsibility to maintain the highest standards of journalism. The current situation, with Ms. Latouff continuing to host prime time TV, constitutes a clear breach of this obligation.

- > I urgently request a comprehensive explanation of the steps the ABC plans to take to rectify this situation and restore the credibility of its reporting. Australians deserve accurate, unbiased information, and it is crucial that swift and decisive action be taken to address this issue.
- > I anticipate your prompt attention to this matter and a thorough investigation into the concerning conduct of Ms. Latouff. At a time when journalism needs to be at its strongest, it is imperative that the ABC upholds its commitment to journalistic integrity.
