- Declarations pursuant to section 21 of the Federal Court of Australia Act 1976 (Cth) (FCA Act) and/or section 562 of the Fair Work Act 2009 (Cth) (FW Act) that Seven Network:
 - a. committed a serious contravention of section 44 of the FW Act as pleaded in paragraph 30 of the SOC;
