A federal government spokesman admits that the meeting between Brittany Higgins and Senator Reynolds should not have taken place in the office where the alleged assault occurred.

Today the Prime Minister was questioned in parliament about the assault and he endorsed the way the case had been handled by government officers including Fiona Brown.
