SUPPLEMENTARY SUBMISSIONS OF THE RESPONDENT ON SETTLEMENT APPLICATION

 An error has been identified in the calculations underlying the table at [132] of the Respondent's submissions of 1 November 2024 (**RS**). The table below is a corrected version of the table. The table is an estimate of the likely final in-hand payments to Eligible Claimants using the Commonwealth's proposed Differentiation Order (see RS [131]) and otherwise using equivalent assumptions to the Applicant's 'Option #1 @8,000 BUFFERED', with assumptions regarding the possible number of Eligible Claimants who may fall into each Sub-Group.

Alternative Differentiation Order

2. If the total number of Eligible Claimants is 7,437 or below (and the same assumed deductions and other assumptions are made), the Commonwealth's proposed Differentiation Order could see the payment to Eligible Claimants in Sub-Group 4 fall below \$10,000. The Commonwealth raises this noting the Applicant's proposal for a 'Minimum Payment' of \$10,000. The below table sets out estimated in-hand payments at different numbers of total Eligible Claimants (keeping all other variables, and the proportion in each sub-group the same) under the Commonwealth's Differentiation Order:

If the Court is concerned to ensure that all Eligible Claimants receive a minimum payment of \$10,000, the Commonwealth's Differentiation Order could be adjusted to reduce the discount in respect of those born after 3 March 1943 to 15% and the discount in respect of the claims of Deceased Eligible Claimants to 15%, so that:
 - 3.1. the payments to Sub-Groups 2 and 3 are 85% of the payments to Sub-Group 1 (instead of 80%), and
 - 3.2. the payments to Sub-Group 4 are 70% of the payments to Sub-Group 1 (instead of 60%).
- 4. The Commonwealth estimates this would produce the following in-hand payments (applying the same assumptions as above):

5. Using these alternative discounts (and applying the same assumptions as above), payments for Sub-Group 4 would fall below \$10,000 if there were 5,523 or less Eligible Claimants.
