- Security Incident reported to Reynolds office on Monday; action taken Tuesday. No
  outside police AFP notified.
- Tuesday morning BL "fired"; B IV follows and rape alleged. Still no police involvement despite a serious crime alleged to being committed in that office.
- When AFP do finally investigate they aren't given the evidence that many others in APH have been given access to which shows BL and B on up to 8 security cameras.
- Pressure of the election given as go to Perth and perhaps continue in employment; or payout another six weeks and you WON'T have a job. She chooses Perth and discontinues AFP case as they've hit a brick wall gaining evidence from APH.
  - No workplace investigation? There is no HR, just the dept of finance.
  - No Workcover investigation? Insurers notified?
  - Here's the EAP after an hour couldn't even get in for 2 months. (Seeing a psych now after our urgings.)
  - Reynolds and FB meet to discuss the assault IN REYNOLDS OFFICE where the assault happened.
  - New job with Cash, that office told of B's assault after CT tip off, privacy breached once again. Cash says it's something she'll have to live with. Other lady in Cash's office says 'Rochelle was always going to talk, you're not going to talk are you.'
  - PMO's office call and check how she is could be seen as caring but for her it's extremely intimidating.
  - In a meeting yesterday B's boss said if she went public he and Cash would back her up.
