Hi Sarah

When we first spoke to Brittany Higgins she hadn't had any counselling or seen any health professional to deal with her trauma.

At my urging after our first discussion she went to her GP and had a Mental Health Plan implemented. This allowed her access to Medicare Psychology counselling sessions.

She was happy with her new psychologist and didn't take up any offer by me to help facilitate any more help.

Brittany had support from the Canberra Rape Crisis Centre at her AFP Belconnen meeting and with Brittany's help I got in contact with this counsellor for corroboration of our story.

After I got in touch with Brittany's counsellor at the Canberra Rape Crisis Centre Brittany then reached out to this counsellor. She has since met with her and maintained contact and continues to seek advice.

I've regularly been checking in with Brittany on a daily basis and she tells me her immediate supports have been:

She is now seeing two counsellors

She has two close friends on speed dial if she has any panics

For her own mental health:

She is living with her father in Qld having moved out of the ACT before the story aired

She is no longer using social media

She has changed her phone number
