All is in order except that upon inspection, Mrs Grimley instructs us that her Miki Moto pearls are in fact those pearls identified as Item 73 [S02583036] in the Pickles Report (not Item 74 [S02583037] as she previously believed). Mrs Grimley recognises Item 73 as her own because the pearls are the correct length and they have an 'M' (for Miki Moto) on the clasp.
