1. I am a Senior Executive Lawyer in the sole employ of the Australian Government Solicitor (**AGS**), the solicitor for the Applicant.
2. Unless stated otherwise, I make this affidavit from my own knowledge. Where I make this affidavit based on information provided to me, to the best of my knowledge I believe that information to be true.
3. I make this affidavit in support of the Applicant's application for interlocutory orders relating to service of the Originating Application filed on 2 August 2024, and its accompanying Concise Statement and Genuine Steps Statement, and any Orders in this proceeding and in relation to the publishing and advertisement of a Notice pursuant to subsection 323(5) of the *Fair Work (Registered Organisations) Act 2009* (Cth) (**FWRO Act**).
4. I have carriage of this proceeding on behalf of the Applicant.

The First Respondent's Annual Return

5. As an organisation registered under the FWRO Act, the First Respondent and each of its Divisions are required to lodge certain information with the Fair Work Commission including on an annual basis.
6. In particular, subsection 233(1)(b) of the FWRO Act requires that the First Respondent lodge, once in a year, a copy of records required to be kept under paragraphs 230(1)(b), (c) and (d) of the FWRO Act, certified by the secretary or other prescribed officer of the organisation (**Annual Return**). Those records include, relevantly:
 - (a) a list of the offices in the First Respondent and each of its branches; and
 - (b) a list of the names, postal addresses and occupations of the persons holding those offices.
7. I am informed by Patrick Coyle, Legal Counsel, Registered Organisations Services Branch Fair Work Commission, that the most recent Annual Return lodged by the First Respondent was on 28 March 2024 (**2024 Annual Return**). The 2024 Annual Return sets out all offices in the First Respondent, together with the name and postal address for the incumbent of each office.
8. Now produced, shown to me, and marked as **Annexure AC-1**, is a copy of the 2024 Annual Return.

9. In addition, subsection 233(2) of the FWRO Act requires that the First Respondent lodge, within a period prescribed by regulations, notification of any change made to the records required to be kept under paragraphs 230(1)(b), (c) and (d), certified by the secretary or other prescribed officer of the organisation.
10. I am informed by Mr Coyle that, since the filing of the 2024 Annual Return, the First Respondent has lodged notifications of changes which are relevant to offices in the First Respondent's Construction and General Division (**C&G Division**) or in relation to the C&G Divisions divisional branches with the following dates, which are produced, shown to me, and marked as indicated:
- (a) 18 April 2024 (**Notifications of Changes 18 April 2024**) (**Annexure AC-2**); and
 - (b) 1 August 2024 (**Notifications of Changes 1 August 2024**) (**Annexure AC-3**).

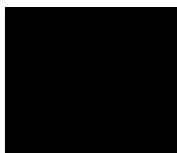
The Individual Respondents

11. There are 269 respondents in the proceeding. Each of the Second to 269th Respondents (**Individual Respondents**) are natural persons who are named in the 2024 Annual Return, Notifications of Changes 18 April 2024 and/or the Notifications of Changes 1 August 2024 as holders of an office in the C&G Division or one of its divisional branches.
12. To the best of my knowledge and belief, based on the 2024 Annual Return, Notifications of Changes 18 April 2024 and the Notifications of Changes 1 August 2024, at the time of filing the Applicant's Originating Application dated 2 April 2024 in this proceeding (**Originating Application**), each of the Individual Respondents was the holder of one or more offices in the C&G Division or one of its divisional branches.
13. Those offices, together with each incumbent, are set out in Annexures B and C of the Originating Application. In particular:
- (a) Annexure B sets out the officers of the following divisional branches of the C&G Division:
 - (i) Victoria-Tasmania Divisional Branch;
 - (ii) South Australia Divisional Branch;
 - (iii) New South Wales Divisional Branch; and
 - (iv) Queensland-Northern Territory Divisional Branch; and

- (b) Annexure C sets out the officers of the:
 - (i) C&G Division Divisional Executive;
 - (ii) C&G Division Divisional Trustees; and
 - (iii) C&G Division Divisional Conference.
- 14. In some cases, a person has been reported as holding more than one office. For example the Fifth Respondent, Jade Ingham, was reported in the 2024 Annual Return as being Divisional President of the Construction and General Division Executive, and Divisional Branch Assistant Secretary in the Queensland Northern Territory Divisional Branch Council. For this reason, an Individual Respondent's name may appear more than once in Annexure B and/or C.
- 15. The Individual Respondents comprise:
 - (a) all of those persons holding the offices identified in Annexures B and C; and
 - (b) persons reported in the 2024 Annual Return as holding offices in the Western Australia Divisional Branch and the Australian Capital Territory Divisional Branch.

Postal addresses for the Individual Respondents

- 16. Consistent with paragraphs 6(b) and 9 above, one of the details in relation to which the First Respondent is required to provide records, certified by the secretary or other prescribed officer of the organisation, is the postal address of every officer of the C&G Division and every officer of each of the C&G Division's divisional branches.
- 17. The Annual Return, Notifications of Changes dated 18 April 2024, and Notifications of Changes dated 1 August 2024, state that the following Individual Respondents have the following postal addresses:
 - (a) for Respondents numbered 2 – 16, 20, 25, 37, 39, 40, 60, 77, 118, 132, 151, 155, 164, 166, 206 – 208, 211, 213, 215, 217, and 219 – 224 : Level 1, 1 Miller Lane, Pyrmont, NSW 2009;
 - (b) for Respondents numbered 11, 12, and 16 – 131 :Level 5, 540 Elizabeth Street, Melbourne, VIC 3000;



- (c) for Respondents numbered 15 and 132 – 150 :Level 1, 32 South Terrace, Adelaide, SA 5000;
- (d) for Respondents numbered 6, 8, 14, and 151 – 205 :Level 2, 63 Miller Street, Pyrmont, NSW 2009;
- (e) for Respondents numbered 5, 7, 13, and 206 – 218 :16 Campbell Street, Bowen Hills, QLD 4006;
- (f) for Respondents numbered 10 and 224 – 252 :80 Beaufort Street, Perth WA 6000; and
- (g) for Respondents numbered 9 and 253 – 269 :Unit 7-10, 8 Cape Street, Dickson, ACT 2602.

Need for an Order of Substituted Service

18. There are 268 Individual Respondents. In my opinion it is impractical, and would be prohibitively expensive, to effect personal service on each Individual Respondent. In my experience, the cost of effecting personal service by using process servers in New South Wales, Victoria, Northern Territory and Queensland (when the work or home address of the person was known) varies from \$206 to \$318 inclusive of GST. Based on this sample, the average cost of each instance of personal service is \$247 including GST, and using this figure personal service of all 268 Individual Respondents could cost in the order of \$66,196 for the disbursements alone. That would be if the work or home address of the person was known. It would be significantly more if the work or home address of the person was not known.
19. Further, apart from the postal addresses referred to in the preceding sections of this affidavit, the Applicant does not presently have contact details for the Individual Respondents that would enable them to be located to effect personal service, and the time and cost involved in attempting to locate all 268 Individual Respondents appears so large as to be inestimable, if they could be located at all.
20. In light of those difficulties, the Applicant seeks from this Honourable Court an order for substituted service under rule 10.24 of the *Federal Court Rules 2011* (Cth). The proposed order would allow for service upon the Individual Respondents:
 - (a) at an email address known to the First Respondent (with a process for the First Respondent to confirm that service has occurred);

- (b) in the absence of service being effected by email by the First Respondent, by prepaid mail to the Individual Respondent's postal address as set out in the Annual Return, Notifications of Changes dated 18 April 2024, and Notifications of Changes dated 1 August 2024 and extracted above at paragraph 17; or
 - (c) otherwise by prepaid mail to the Applicant's home address or work address.
21. I note that orders for substituted service were made by the Honourable Justice Flick in the application previously made under s 323 of the FWRO Act in relation to the East Branch of the Health Services Union. Now shown to me and marked **Annexure AC-4** is a copy of the orders for substituted service dated 11 May 2012 made by Justice Flick in proceeding NSD621/2012 *Christopher Paul Brown & Ors v Health Services Union & Ors*. In so far as they provide for service by prepaid post, the orders proposed by the Applicant in this case have been adapted from those orders.

Proposed Notice

22. The Applicant seeks from this Honourable Court an order pursuant to subsection 323(5) of the FWRO Act in relation to the publishing and advertisement of a Notice in accordance with Annexure D to the Originating Application.
23. The proposed orders are for publishing and advertisement of the Notice on the website of the Fair Work Commission (www.fwc.gov.au), in the major daily newspapers of the capital cities of each State and Territory, and on the websites and social media accounts (including Facebook and X previously known as Twitter) of the CFMEU, the C&G Division, and the each of the C&G Division's Divisional Branches.

Applicant's proposed interlocutory orders

24. The Applicant proposes to send to the chambers of his Honour Justice Wheelahan, with a copy to the solicitors for the First Respondent and other persons of whom the Applicant is aware who have expressed to the Court an intention to intervene or to apply to intervene, a copy of the Applicant's proposed interlocutory orders. That email will be sent as soon as practicable on the afternoon or evening of 5 August 2024.



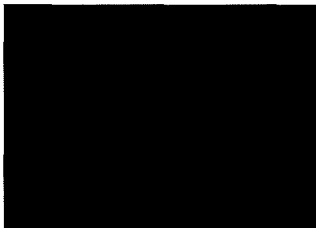
