I, Caitlin Maria Murray of Level 40, Governor Macquarie Tower, 1 Farrer Place, Sydney NSW 2000, Solicitor, say on oath:

- I am a partner of the firm of solicitors, MinterEllison and the solicitor for the first applicant, Westpac Banking Corporation (WBC) and the second applicant Westpac New Zealand Limited (WNZL) (together, Westpac).
- Exhibited to me at the time of swearing this affidavit is a paginated bundle of documents marked 'Exhibit CMM-24' (CMM-24). Throughout this affidavit I make reference to documents which appear at CMM-24.

## **Correspondence with Mr Paul Hunt**

- 3. On 6 December 2021, leave was granted for the issue of a subpoena to Rocco Vincenzo Panetta (**Mr Panetta**) in relation to receipt of funds by Panetta Lawyers from National Voice and Data Pty Ltd (the **Subpoena**). A copy of the letter addressed to Mr Paul Hunt (**Mr Hunt**), Mr Panetta's solicitor, enclosing the Subpoena, together with a copy of the subpoena is at pages 1 to 12 of CMM-24.
- 4. In the period from 6 December 2021 to 2 March 2022, MinterEllison and Mr Hunt exchanged correspondence in relation to the Subpoena. A copy of these emails is at pages 13 to 39 of CMM-24.
- 5. In his email to MinterEllison on 16 February 2022, Mr Hunt stated that a message had been sent to Mr Papas about the bundle of documents marked as subject to a potential claim for privilege, but that it was unclear whether Mr Papas had received that message: see page 29 of CMM-24.
- 6. On 2 March 2022, Mr Panetta produced two packets of materials to the Court, being subpoena packet S74 and subpoena packet S75. Subpoena packet S75 was marked as subject to a potential claim for legal professional privilege. Mr Panetta had attempted to produce these documents to the Court on 15 February 2022.
- 7. On 9 March 2022, Registrar O'Connor granted leave to the parties to access subpoena packet S74 only. To date, no access orders have been made in relation to packet S75.
- MinterEllison and Mr Hunt exchanged further correspondence in relation to the Subpoena in the period 8 March 2022 to 29 March 2002. A copy of this correspondence is at pages 40 to 43 of CMM-24.


#### **Correspondence with O'Brien Criminal & Civil Solicitors**

- 9. I have been informed and verily believe that on 16 March 2022, Alana Galasso, a solicitor of MinterEllison under my supervision, received a phone call from Sidnie Sarang of O'Brien Criminal & Civil Solicitors (**O'Brien Solicitors**) and that during this call, Ms Sarang stated that O'Brien Solicitors had spoken to Mr Papas about subpoena packet S75 and whilst not yet formally retained, anticipated that a formal retainer would be arranged shortly.
- 10. In the period from 16 March 2022 to 29 March 2022, MinterEllison and O'Brien Solicitors exchanged correspondence in relation to subpoena packet S75 and O'Brien Solicitors' representation of Mr Papas. A copy of these emails is at pages 44 to 50 of CMM-24.
- 11. On 29 March 2022, MinterEllison received an email from O'Brien Solicitors stating that a Notice of Acting had been filed in the proceedings. A copy of this email is at page 51 of CMM-24. An unsealed copy of the Notice of Acting was provided to MinterEllison on 30 March 2022 and is at pages 52 to 55 of CMM-24.
- 12. On 30 March 2022, Ms Galasso sent a further email to Ms Sarang of O'Brien Solicitors, to which I was copied. A copy of this email is at page 56 of CMM-24.
- 13. On 30 March 2022, Registrar Cridland made the orders at pages 57 to 60 of CMM-24.
- 14. On 1 April 2022, MinterEllison sent an email to all legal representatives in these proceedings, including Mr Hunt, providing a copy of the orders of Registrar Cridland made on 30 March 2022 and the orders of Justice Lee dated 1 April 2022 listing the matter for a case management hearing on 13 April 2022.
