I, Jennifer El-Azzi, Compliance Manager, say on oath:

- I am currently employed by the Commonwealth Bank of Australia (CBA) as a Commonwealth Securities Limited Compliance Manager (CommSec) (Compliance Manager). I have held this role since 15 November 2019 and have been employed by CBA since 5 December 2016.
- 2. This is the second affidavit I have sworn in these proceedings. I swore an earlier affidavit on 22 March 2021.

CommSee database

- 3. At paragraph 8 of my earlier affidavit, I described the CommSee database and the Customer Service Console (CSC) database. In the paragraphs below, I provide some additional information regarding the two databases.
- 4. The CommSee database contains broader customer information than the CSC database. The CommSee database contains customer information relating to accounts or products that a customer holds across the broader Commonwealth Bank. For example, a search of the CommSee database will generate search results indicating whether a particular customer has any credit cards, home loans or other business loans with the Commonwealth Bank. A search of the CommSee database will also generate search results indicating whether a particular customer has any share trading accounts with CommSec.
- While it is possible to search the CommSee database to determine whether a customer holds a CommSec account, the CommSee database does not contain specific information relating to a customer's CommSec account, such as their shareholdings or trading history. That information is held in the CSC database.
- 6. In contrast to the CommSee database, the CSC database only contains information concerning a customer's share trading account with CommSec. Accordingly, a search of the CSC database will definitively tell me:

- (a) whether or not there exists a CommSec account with a particular account number; and
- (b) if a CommSec account with a particular account number exists, the name of the party that holds (or held) the CommSec account.
- 7. It is not possible for a CommSec account number to be stored in the CommSee database without it also being stored in the CSC database. Accordingly, if a search of the CSC database using a purported CommSec account number generates zero matches, it is unnecessary to conduct a secondary search of the CommSee database in respect of that same purported CommSec account number.

Clarification of paragraphs 10 and 17 of my earlier affidavit

- 8. At paragraph 10 of my earlier affidavit I stated that I filled out the information in columns I, J and K of the Excel spreadsheet found behind Tab 1 of Exhibit JE-1. In respect of the Excel spreadsheet I say:
 - (a) Column "I" indicates whether the account number provided to me by ASIC as referred to in paragraph 9 of my earlier affidavit was located by me within the CSC database. As mentioned in paragraph 9, that account number appeared in the "Portfolio Statement" and/or the "Transaction Summary Statement" referred to in paragraph 9 and exhibited to my earlier affidavit. In the event such number matched a CommSec account number for the relevant individual I recorded "Yes" in Column I against the relevant name of the individual or entity. Where I found no match, I recorded "No" against the relevant name of the individual or entity;
 - (b) Column "J" indicates whether account number provided to me by ASIC and appearing in the "Portfolio Statement" and/or the "Transaction Summary Statement" referred to in paragraph 9 of my earlier affidavit was a genuine CommSec Account. In the event such number matched a CommSec account number for the relevant individual I recorded "Yes" in Column I against the relevant name of the individual or entity. Where I found no match, I recorded "No" against the relevant name of the individual or entity;
 - (c) Column "K" records my comments that I made in respect of my searches for each individual or entity set out in the spreadsheet.
- 9. For the avoidance of doubt, I incorporate the information contained in columns I, J and K of the Excel spreadsheet into the body of this affidavit and adopt that information as if it formed part of this affidavit.

- 10. At paragraph 17 of my earlier affidavit, I summarised the results of my searches of the CSC database in respect of the account numbers ASIC provided to me. As mentioned, those results are recorded in columns I, J and K of the Excel spreadsheet. For the avoidance of any doubt, I clarify the following.
 - (a) In respect of paragraph 17(a) of my earlier affidavit, the documents at Tabs 3, 4, 18, 19, 39, 43 and 120 of Exhibit JE-1 contain only a "Portfolio Statement" referred to in paragraph 9 of my earlier affidavit. In respect of each individual or entity to which the documents behind those tabs relate, I received from ASIC only a "Portfolio Statement" containing the relevant account number.
 - (b) In respect of paragraph 17(b) of my earlier affidavit, the documents at Tabs 5 and 20 of Exhibit JE-1 contained only a "Transaction Summary Statement". In respect of each individual or entity to which the documents behind those tabs relate, I received from ASIC only a "Transaction Summary Statement" containing the relevant account number.
 - (c) In respect of paragraph 17(c) of my earlier affidavit, the documents at Tabs 6, 7-17, 21 to 38, 40, 42, 44 to 71, 73, 75 to 76, 91, 94 to 95, 98 to 100, 107 to 110, 112, 119 and 122 Tab 123 of Exhibit JE-1 contain both a "Portfolio Statement" and "Transaction Summary Statement". In respect of each individual or entity to which the documents behind those tabs relate, I received from ASIC both a "Portfolio Statement" and a "Transaction Summary Statement" containing the relevant account number. I note that in my earlier affidavit, I included the documents at Tabs 5 and 39 in this category. However, this was a typographical error. The document at Tab 5 contained only a "Transaction Summary Statement" and is referred to at paragraph 8(b) above. The document at tab 39 contained only a "Portfolio Statement" and is referred to at paragraph 8(a) above.
 - (d) In respect of paragraph 17(d) of my earlier affidavit, the documents at Tabs 41, 72, 74, 77 to 90, 92 to 93, 96 to 97, 101 to 106, 111, 113 to 118 and Tab 121 of Exhibit JE-1 contain both a "Portfolio Statement" and "Transaction Summary Statement". In respect of each individual or entity to which the documents behind those tabs relate, I received from ASIC both a "Portfolio Statement" and a "Transaction Summary Statement" containing the relevant purported account number.
- 11. In respect of paragraph 21 of my earlier affidavit, when I refer to the "Portfolio Valuations" I refer to the "Portfolio Statement" and/or the "Transaction Summary

Statement" referred to in paragraph 9 of my earlier affidavit. To clarify as a result of my investigations described in my earlier affidavit:

- (a) There was only one instance in which the account number I used from the Portfolio Valuations provided to me by ASIC as described in paragraph 9 of my earlier affidavit matched an account name within the CSC database.
- (b) In most cases, the account numbers from the Portfolio Valuations provided to me by ASIC as described in paragraph 9 of my earlier affidavit matched a genuine CommSec account within the CSC database however the respective account details did not match the name set out in those Portfolio Valuations. That is, the account numbers set out in the Portfolio Valuations were genuine Commsec account numbers however they did not match the Commsec investor purported to be named in the Portfolio Valuations. This was so for the individuals and entities referred to in cells H4 H41, H43 H72, H74, H76 H77, H92, H95 H96, H99 H101, H108 H111, H113, H120 H121 and H123 H124 of the Excel spreadsheet.
- (c) In some cases, the account numbers asserted in the Portfolio Valuations matched no account number in the CSC database and accordingly I concluded that those purported accounts do not exist. For example the investors referred to at cells H42, H73, H75, H78, H91, H93, H94, H97, H98, H102 - H107, H112, H114 - H119, H122.

- 14. On 27 April 2021, I searched the CSC database in order to determine whether there are CommSec accounts for the relevant investor bearing the purported CommSec account numbers on the Portfolio Statements and Transaction Summary Statements.
- 15. For each search, I took the steps outlined at paragraph 16 of my earlier affidavit.
- 16. My searches of the CSC database returned the following responses:
 - the search results returned a valid CommSec share trading account. However, the account details do not match the name listed on the "Transaction Summary Statement" and "Portfolio statement". The CommSec account with the account number 786549 belongs to an unrelated third party.
 - as noted at paragraph above, the document provided to me consisted of only a "Portfolio Statement" containing the account number. The search results returned a valid CommSec share trading account. However, the account details do not match the name listed on the "Portfolio statement". The CommSec account with account number 529753 belongs to an unrelated third party.
 - the search results returned a valid CommSec share trading account. However, the account details do not match the name listed on the "Transaction Summary Statement" and "Portfolio statement". The CommSec account with account number 787037 belongs to an unrelated third party.
