THE COURT ORDERS THAT:

1. Pursuant to s 37AF of the *Federal Court of Australia Act 1976* (Cth), publication or disclosure be prohibited other than to:
 - (1) the applicant, the first respondent, Mr James Hooke, the solicitors and counsel for the applicant and the first respondent, and any solicitor or counsel for the second respondent that is not acting for the second respondent in Federal Court of Australia proceedings NSD 206 of 2021; or
 - (2) any other person where that person is receiving the publication or disclosure only for the purposes of instructing or acting or advising in relation to a complaint to, or investigation by, or proceedings in, a professional disciplinary body,on the grounds that the order is necessary to prevent prejudice to the proper administration of justice and to preserve legal professional privilege over confidential communications, of:
 - (a) the concise statement other than in the redacted form in the redacted version of the Court Book provided to the Associate to Thawley J via email on 18 June 2021 and filed on 23 June 2021 (**Redacted Court Book**);
 - (b) the concise response of the first respondent other than in the redacted form in the Redacted Court Book;



- (c) any affidavits filed on behalf of a party, including exhibits or annexures thereto, other than any redacted forms in the Redacted Court Book;
 - (d) the opening submissions filed on behalf of the applicant other than in the redacted form in the Redacted Court Book;
 - (e) other submissions filed on behalf of the applicant and second respondent other than in the redacted forms filed on behalf of those parties;
 - (f) documents tendered in evidence as exhibits 2 and 3;
 - (g) documents tendered in evidence as exhibit 6, other than the redacted form of exhibit 6 annexed to these orders;
 - (h) reasons for judgment delivered in closed court; and
 - (i) transcripts of proceedings conducted in closed court other than:
 - a. page 151, line 29 to page 159 of the transcript, recording part of the hearing in closed court on 25 May 2021; and
 - b. pages 224 to 226 of the transcript, recording part of the hearing in closed court on 26 May 2021.
2. Within 21 days, unless a notice of appeal has been filed and served in accordance with rule 36.03 of the *Federal Court Rules 2011* (Cth), the legal representatives for the second respondent are to destroy or cause to be destroyed any copies in their possession or control of:
- (1) any unredacted forms of the documents referred to in Order 1; and
 - (2) any documents reproducing, in part or in whole, the redacted parts of those documents, other than documents created by the legal representatives for the second respondent during the course of their engagement by the second respondent for professional use during these proceedings.

Amy has suggested Thursday or late Saturday afternoon as possible times for ga to raise a glass of wine to Kate - I can probably do Saturday if that suits you? Otherwise feel free to propose a convenient time as your schedule will be the busiest! I can do Thurs, Fri or Sun next week but am then in Adelaide for the week of July 20 (all going well on the Covid front).

Wed, 8 Jul, 8:07 am

Hello! I'm in Canberra after doing writers festival launch with Pyne. In Byron for the rest of the week but could do Thursday Fri or Sunday next week (Thurs or Fri evening, Sunday any time)
Are you at my house btw? And did Lou manage to [REDACTED]

Heading to your house at 11am, which will feel slightly odd in your absence! I confess I hadn't really imagined being interviewed but think the idea is that, with the new lockdown, to capture as much as possible while it's possible to do so and then assess what's useful. As of yesterday afternoon, [REDACTED] so I think the plan is to do a remote interview in the studio. Great re next week - will check in with Amy and get back to you. Despite my scepticism, our Zoom memorial on Saturday was actually really lovely. Have fun tonight with Pyne!

I was at an event with Paul Fletcher. He didn't know about Kate. He responded to the news a bit unreadably. 🙄

Ha last time you were interviewed in my house it was swathed in scarves after our feminist vandalism spree ... remember that? Some of the furniture is probably the same - some eagle eyed viewer might spot it 🤔
