- 1. am formerly the solicitor for the Second Respondent ("Mr Papas").
- 2. In making this affidavit, I do not intend, nor do I have instructions to waive any client legal privilege of Mr Papas with respect to communications between him and me.
- 3. Exhibited to this affidavit is a paginated bundle of documents marked exhibit 'RVP-01' (RVP-01) containing documents to which I refer throughout this Affidavit.
- 4. Exhibited to this affidavit is a confidential exhibit marked exhibit 'RVP-02' (RVP-02).

Background

- 5. I am an Australian Legal Practitioner within the meaning of *Legal Profession Uniform Law* having been admitted to practice in 1999 in the Supreme Court of NSW and the Federal and High Courts of Australia.
- 6. As an Australian Legal Practitioner I am obliged to keep confidential the information given to me by my clients unless there is an exception to that obligation. Further, I am obliged to ensure that confidential information provided to me by my clients or former clients is not disclosed in accordance with the obligations set out in Rule 9 of the Legal Profession Uniform Law Australian Solicitors' Conduct Rules 2015.

Australian Mobile Number for Mr Papas

- 7. I met Mr Papas in 2012 or 2013 when his company sold me a printer. It was at that time that Mr Papas provided me with a mobile phone number by which I could contact him ("Australian Mobile Number").
- 8. Between about 2013 and November 2020, I had no contact with Mr Papas via the Australian Mobile Number or any other point of contact.
- 9. For a short period of time in about November / December 2020 and in late June 2021 until early July 2021 Mr Papas and I communicated with each other using the Australian Mobile Number.

Acting for Mr Papas

10. On 1 July 2021 I commenced acting as the solicitor for Mr Papas in these proceedings (Number NSD 616 of 2021) (the "proceedings"). I caused to be filed a Notice of Address for Service in the proceedings on that date.

11. On 8 July 2021 I filed a Notice of Acting in the proceedings.

Email address

- 12. On 2 July 2021, and in the course of my retainer as solicitor for Mr Papas, Mr Papas provided to me an email address to use to correspond with him in relation to the proceedings. That email address is the email address deposed to in paragraphs 8, 11 and 12 of the affidavit of Caitlin Maria Murray sworn 2 October 2021.
- 13. The email address identified in Ms Murray's affidavit is the only personal email address I have for Mr Papas. There were two other email addresses used by Mr Papas of which I am aware with the domains forumgroup.com.au and iugis.com ("Company Email Addresses"). I have not received emails from the Company Email Addresses since the commencement of the proceedings. It is my understanding the Company Email Addresses are recorded in the material currently held by the liquidators of the respondent companies.

Greek Phone Number

- 14. On 2 July 2021, and in the course of my retainer as solicitor for Mr Papas, Mr Papas provided to me a phone number with the country code +30 which I understand to be for phone numbers issued in Greece (the "Greek Phone Number"). Aside from the Australian Mobile Number and the Greek Phone Number I have no other telephone number for Mr Papas.
- 15. Mr Papas provided the Greek Phone Number to me on the express condition that I was not to disclose that phone number to any other person.
- 16. The details of the Greek Phone Number are exhibited to me at page 1 of Exhibit RVP-02 over which I respectfully seek that confidentiality orders be made.

Email, Telephone, WhatsApp, Signal, Microsoft Teams and Zoom

- 17. From the date Mr Papas provided to me the Greek Phone Number, Mr Papas and I have communicated with each other using it primarily via the telephone network and via a messaging platform known as WhatsApp.
- 18. Mr Papas also requested I use a messaging application called Signal. I communicated with Mr Papas via Signal for a short time only.

- 19. The contact details by which I communicated with Mr Papas via both WhatsApp and Signal platforms was via a user account and the Greek Phone Number was used for that purpose. Because of the nature of the messaging platforms, and the use by Mr Papas of the Greek Phone Number, there was no user name or other electronic address by which I communicated with him on those platforms.
- 20. On or about 2 July 2021 I created a group chat on the WhatsApp platform which included myself, a barrister and the Greek Phone Number by which I contacted Mr Papas. I labelled that group chat "Legal Advice Bill Papas".
- 21. Other than email, the telephone service, WhatsApp and Signal, I communicated with Mr Papas alone and in conference with counse! over Microsoft Teams and Zoom using his email address, which, as I depose above is the same email address deposed to in paragraphs 8, 11 and 12 of the affidavit of Caitlin Maria Murray sworn 2 October 2021.

Last Known Address of Mr Papas

22. The last known address have for Mr Papas is 23 Margaret Street, Rozelle NSW 2039.

Resources of the Applicant

23. On 15 July 2021 I read the affidavit of Caitlin Maria Murray filed in the proceedings and observed that the Applicant and their solicitors are able to obtain a substantial amount of information about Mr Papas, including addresses in Greece. I am not aware of Mr Papas' address or addresses in Greece.

Potential Criminal Proceedings

- 24. On 15 July 2021 I read the affidavit of Vincent Damiano filed in the proceedings. From reading Mr Damiano's affidavit, I understood, among other things, that on 30 June 2021 Mr Damiano reported to New South Wales police a fraud against the Applicant.
- 25. Since 15 July 2021 I have read a number of media articles which refer to an investigation of Mr Papas by the NSW Police.
- 26. On the basis of the matters to which I depose in the two paragraphs immediately above, I am concerned that, if the Greek Phone Number is read in open court, or provided to the Applicant without strict orders as to its confidentiality, that Mr Papas' right to the presumption of innocence will be placed in jeopardy and he may be the subject of harassment by media outlets.

Ceasing to Act for Mr Papas

- 27. On 20 September 2021 I served Mr Papas with a Notice of Intention to Cease to Act dated 7 September 2021 which I prepared in accordance with Rule 4.05 Federal Court Rules 2011. I served that Notice by email to the email for Mr Papas identified in the affidavit of Ms Murray. In the same email I provided Mr Papas with a Notice of Ceasing to Act dated 16 September 2021.
- 28. On 27 September 2021 I filed the Notice of Ceasing to Act by electronic filing.
- 29. I considered that from the point of filing of the Notice of Ceasing to Act that I was no longer the solicitor for Mr Papas and no longer acted for him in the proceedings.
- 30. On 27 September 2021 I received from the registry a sealed copy the Notice of Ceasing to Act. A copy the sealed Notice of Ceasing to Act is at pages 3 to 4 of Exhibit CMM-15.
- 31. On 29 September 2021 at 9.10 a.m. I sent the sealed Notice of Ceasing to Act by email to Mr Sommer of Minter Ellison, the solicitors for the applicant in the proceedings. The Notice of Ceasing to Act contains the last address of Mr Papas as known to me. A copy of the email from me to Mr Sommer is at pages 1 to 2 of Exhibit CMM-15.

After Ceasing to Act for Mr Papas

- 32. Since ceasing to act for Mr Papas:
 - (a) Mr Papas has attempted to contact me approximately five times via WhatsApp using the Greek Telephone Number;
 - (b) On 3 October 2021 I accepted a WhatsApp call from Mr Papas and told him that I no longer act for him and cannot speak with him about the proceedings; and
 - (c) I have no intention of corresponding with Mr Papas further in relation to the proceedings.

Correspondence Prior to Case Management Hearing on 1 October 2021

33. On 29 September 2021 at 2.03 p.m. Mr Sommer sent me an email. A copy of the email from Mr Sommer to me is at page 1 of Exhibit CMM-15.

34. On 30 September 2021 at 10.16 a.m. Mr Sommer sent me the listing for the case management hearing set down for 1 October 2021. A copy of the email from Mr Sommer to me is at pages 1 to 3 of Exhibit RVP-01.

- 35. Both the communications sent to me by Mr Sommer on 29 and 30 September 2021 were sent to me after I had sent to Mr Sommer the filed Notice of Ceasing to Act.
- 36. On 30 September 2021 at 7.40 p.m. I was copied on correspondence to the Associate for Justice Lee. A copy of that email is at pages 6 to 7 of Exhibit CMM-15. The email was not directed to me. I read the email and the affidavit of Ms Murray which was attached to it. On reading Ms Murray's affidavit, I was made aware for the first time that the Applicant's solicitors had an issue of not having an address for Mr Papas. This was the first time the Applicant had indicated it may raise an issue with the Court about Mr Papas' address.
- 37. On 30 September 2021 at 8.16 p.m. I responded to the 29 September 2021 email from Mr Sommer. A copy of that email is at page 5 of Exhibit CMM-15.
- 38. On 30 September 2021 at 8.41 p.m. I sent a further email asking Mr Sommer to bring my emails to the attention of the Court as I am not a party to the proceedings and I am no longer acting for Mr Papas in the proceedings. A copy of that email is at page 6 of Exhibit CMM-15.
- 39. On 1 October 2021 at 10.12 a.m. Mr Sommer sent me an email with submissions concerning an application for Orders against me to have me re-file a Form 8 of Notice of Ceasing to Act with details which I do not have. A copy of that email is at pages 4 to 11 of Exhibit RVP-01.
- 40. On 1 October 2021 at 10.32 a.m. Mr Sommer sent me a further email with submissions concerning an application for Orders against me to have me re-file a Form 8 of Notice of Ceasing to Act with details which I do not have. A copy of that email is at page 13 of Exhibit CMM-15.
- 41. On 1 October 2021 at 11.21 a.m. I sent an email to all parties in the proceedings stating my position, which included the information that I did and did not have, and asking for my correspondence to be provided to the Court. A copy of that email is at pages 14 to 15 of Exhibit CMM-15.
