- I am a Partner in the Restructuring practice of McGrathNicol, a Chartered Accountant (admitted as a member of the Chartered Accountants Australia and New Zealand) and a Registered Liquidator. I, together with Jason Preston and Katherine Sozou are the joint and several voluntary administrators of the Plaintiffs (*Voluntary Administrators*).
- 2. I believe that the information contained in this affidavit is true.

- 3. I make this affidavit in support of the Plaintiffs' Originating Process dated 23 July 2021 seeking orders that, among other things:
 - (a) Each of the Plaintiffs (*Relevant Entities*) be wound up pursuant to s 461(1)(k) of the Corporations Act 2001 (Cth) (*Act*);
 - (b) Jason Preston and I of McGrathNicol be appointed as joint and several liquidators of the Relevant Entities; and
 - (c) The administrations of each of the Relevant Entities come to an end under s 447A of the Act and s 90-15 of the Insolvency Practice Schedule (Corporations); and
- I refer to my first affidavit affirmed 23 July 2021 and filed in these proceedings (*First Affidavit*).

Activities conducted by the Relevant Entities

5. I refer to paragraph 9 of my First Affidavit. Financial position of the Relevant Entities

- 6. The first creditors' meeting was convened on 20 July 2021 which had over 180 attendees including creditors and proxyholders.
- 7. Based on the information provided to me by the former voluntary administrators, the voluntary administrators received mor than 140 proofs of debt, including:
 - (a) 34 proofs of debt totalling \$801,980 from employee priority creditors;
 - (b) 23 proofs of debt totalling \$258,602,380 from related parties; and
 - (c) 71 proofs of debt totalling \$4,205,578 from unsecured creditors (excluding the major financiers).
- 8. Even excluding the claims of the major financiers, based on my investigations to date I am not aware of any of the Relevant Entities entities holding assets sufficient to pay out the claims that were admitted for voting purposes.
- 9. I have caused McGrathNicol's forensic team to commence a process of analysing how the funds provided by Westpac Banking Corporation, Societe Generale, and SMBC Leading Lending and Finance Inc to FF and/or Forum Enviro (Aust) Pty Ltd (In Provisional Liquidation) ACN 607 484 364 (*FEA*) (as applicable) have been applied. It appears that those funds were, in the large part, received by Forum Group Financial Services Pty Ltd (In Provisional Liquidation) ACN 623 033 705 (*FGFS*) directly from Forum Finance and/or FEA. From the analysis that has been undertaken to date, as well as transfers to a range of third parties, FGFS transferred those funds to at least the following entities:

- (a) 14 James Street Pty Ltd, the Second Plaintiff;
- (b) 26 Edmonstone Road Pty Ltd, the Third Plaintiff;
- (c) 5 Bulkara Street, the Fourth Plaintiff;
- (d) 6 Bulkara Street, the Fifth Plaintiff;
- (e) Aramia Holdings, the Sixth Plaintiff;
- (f) Eros Management, the Seventh Plaintiff;
- (g) Forum Group Pty Ltd, the Tenth Plaintiff;
- (h) lugis Pty Ltd, the Eighteenth Plaintiff;
- (i) lugis Waste Solutions Pty Ltd, the Nineteenth Plaintiff; and
- (j) Spartan Consulting Group, the Twenty-Fourth Plaintiff.

Circular to Creditors of the Relevant Entities

- 10. On 26 July 2021, I caused a circular to creditors and suppliers (*Circular*) to be sent to the known email and postal addresses of the creditors of the Relevant Entities, being those individuals and entities who appeared in the books and records of the Relevant Entities, and those who submitted a proof of debt the first creditors' meeting. The Circular was sent to:
 - (a) By email to 362 creditors for whom the books and records of the Relevant Entities recorded email addresses; and
 - (b) By post to 525 creditors for whom the books and records of the Relevant Entities only recorded postal addresses (*Postal Creditors*).

Circular to Creditors and Suppliers

I advise that:

- on 21 July 2021, Kathy Sozou, Jason Preston and I were appointed Voluntary Administrators (**Administrators**) pursuant to s436E(4) of the Corporations Act 2001 (the **Act**) of the 24 entities listed in Appendix A, including The Forum Group of Companies Pty Ltd, replacing Domenico Alessandro Calabretta, Grahame Robert Ward and Thyge Trafford-Jones of Mackay Goodwin as administrators (**Former Administrators**) of these same entities; and
- on 22 July 2021, the Administrators were also appointed Voluntary Administrators pursuant to s436E(4) of the Act of Forum Group Pty Ltd, replacing the Former Administrators.

In addition to the above and as outlined in Annexure A, Jason Preston and I were previously appointed liquidators (**Liquidators**) over other related entities on 9 July 2021 and 15 July 2021 respectively.

Immediate objectives

The Administrators and Liquidators (collectively **the Appointees**) have assumed control of each of the Companies' affairs and have entered into possession of their assets.

The Appointees are presently undertaking an urgent financial and operational assessment on a business-bybusiness basis. The Appointees' objectives are to work closely with employees, suppliers and customers to quickly stabilise operations and to determine the appropriate strategy for each business unit.

Accordingly, suppliers and contractors are asked to not make any further supply or provision of services to the entity they trade with, without receipt of a purchase order signed by one of the Appointees, or their authorised signatories (**Appointees' Purchase Order**). Samples of authorised signatories are attached at Annexure B.

All supplies made against an Appointees' Purchase Order issued from the appointment date of the Appointees' (as outlined in Annexure A) and beyond will be paid on normal terms.

Procedure for ongoing supply

Please adopt the following procedures with regard to the Companies' accounts:

- close your present account as at the date of the Appointees' appointment, as noted for each specific entity in Annexure A; and
- open a new account in the name of the respective entity (or entities) with whom you trade, with "Administrators Appointed" or "Liquidators Appointed" noted on the account name (subject to the appointment type for the entity you trade with, as outlined in Annexure A). For example, if you

previously had an account with "Forum Direct Pty Ltd", a new account should be opened in the name of "Forum Direct Pty Ltd (Administrators Appointed)".

Payments made by the Appointees must be applied against debts incurred by the Appointees (i.e. against supplies made on or after the appointment date noted in Annexure A) and cannot be applied against any pre-appointment debt owed to you by the entity you trade with.

Additionally, if you are presently a customer of Forum and its related entities as well as a creditor, any goods or services supplied to you by the Companies following the Appointees' appointment must be paid for in full in accordance with the Companies' normal trading terms. Any goods or services provided by Forum and its related entities are provided in accordance with the above condition.

Please note the following in relation to Forum and its related entities:

- For entities in Administration, any further credit properly incurred for goods and services supplied to the respective entities in administration will be a liability of the Administrators. This will only be for goods and services ordered via a valid Appointee' Purchase Order, for the period following the Administrators' appointment.
- For entities in liquidation, any further credit properly incurred for goods and services supplied to the respective entities in Liquidation represents a priority cost of the winding up of this entity, but is not a liability of the Liquidators personally. This priority will only be for goods and services ordered via a valid Appointee' Purchase Order, for the period following the Liquidators' appointment.
- In the event you have a signed purchase order from the Former Administrators, the Former Administrators remain liable for any costs incurred by them for the period of their appointment. You will need to contact the Former Administrators regarding payment for any amounts incurred by them during the period of their appointment.
- Under the Pay As You Go regime, we will be obliged to withhold 46.5% from payments to suppliers who do not quote a current Australian Business Number (**ABN**). Please ensure that a current ABN is quoted for each supply made by you.
- Input tax credits for payments made to registered suppliers cannot be claimed until such time as a
 compliant tax invoice has been received. Accordingly, the Appointees expect suppliers to provide a
 GST compliant tax invoice prior to payment of supplies you make to the Companies.

For the avoidance of doubt, the Appointee's are not liable for any costs incurred prior to their respective appointment dates for each of the Companies, as outlined in Annexure A.



Court application to place certain of the Companies into liquidation

The Administrators of the respective Companies in voluntary administration have filed an application in the Federal Court of Australia (**Court**) to have:

- 1. each of the Companies in voluntary administration listed in Annexure A (except for Autonomous Energy Pty Ltd) wound up pursuant to section 461(1)(k) of the Act (the 'just and equitable' ground);
- 2. Jason Preston and I appointed as joint and several liquidators (**Proposed Liquidators**) of these respective entities; and
- 3. the voluntary administrations of these respective entities end upon the appointment of the Proposed Liquidators.

In the event that the Court is minded to make those orders, the effect would be that the voluntary administrations would come to an end and these respective entities would go into liquidation.

The reasons for the Administrators seeking orders that these respective entities be placed into liquidation include that:

- the outcome of the voluntary administration process is, in the Administrators' view, in all likelihood that the creditors would vote to put these respective entities into liquidation; and
- by having these respective entities wound up now, the additional costs of the voluntary administration process (which arise from matters such as the costs of preparing reports to creditors and convening meetings) would be avoided.

In the event that you would like a copy of the materials that the Administrators have filed with the Court in support of that application, please let us know by return email and we will provide you with an electronic copy.

Please be advised that the hearing for the application is listed before the Honourable Justice Lee of the Federal Court of Australia on **Wednesday 28 July 2021 at 3:00pm**.

In the event that you wish to attend that hearing, whether to make submissions to the Honourable Justice Lee or to observe, please let us know and we will provide you with the details of the Federal Court hearing once they are made available. We expect that the hearing will take place over Microsoft Teams.

Other matters and contact details

Details of the Second Meeting of Creditors will be provided to creditors separately (noting this will be subject to the outcome of the Court hearing discussed above).

We will liaise with the Former Administrators regarding transition of the Companies' books and records in their possession, including all creditor proofs of debt received. Notwithstanding, should you wish to submit a proof of debt with the Appointees, please contact my staff at forum@mcgrathnicol.com and a blank proof of debt can be provided to you.

A copy of the "Insolvency information for directors, employees, creditors and shareholders" information sheet issued by the Australian Securities and Investments Commission (**ASIC**) is also enclosed at Annexure C for your information.
