Societe Generale v Forum Finance Pty Limited (In Liquidation) & Ors

Applicant's Supplementary Written Outline of Opening Submissions

Capitalised terms used here are as defined in the Opening Submissions.

- 1. The proceedings brought by SG are being heard concurrently with proceedings brought by Westpac and SMBC. Each proceeding was formally called outside of Court on the morning of the first day of hearing. There was no appearance by Mr Papas. Mr Papas is the second respondent in the SG Proceeding.
- 2. As a consequence, SG seeks the **attached** orders for the proceedings to proceed generally against Mr Papas despite his absence. The Court has this power under rule 30.21(1)(b)(i) of the *Federal Court Rules 2011* (Cth) (**FCR**). The principles applicable to r 30.21(1)(b)(i) of the FCR are correctly set out in Westpac's supplementary submissions dated 6 December 2022 at [18] (*WBC/SMBC Court Book tab B.97; MIN.5000.0019.0007 at 0012*).
- 3. Mr Papas previously appeared in the proceedings through his solicitor Rocco Panetta: *Affidavit of Ian Timothy Bolster sworn on 9 August 2022 (Bolster 1) (SG Court Book* tab D7) at [10] and [12] (CB 1347).
- 4. On 22 July 2021, whilst Mr Papas was legally represented in the proceedings, the Court made orders that subject to further order, the Westpac, SMBC and Societe Generale proceedings were to be case managed together. No such further order was made.
- 5. Mr Panetta served a Notice of Ceasing to Act on 1 October 2021: Bolster 1 (SG Court Book tab D7) at [15] (CB 1348).
- 6. On 14 October 2022, the Court made orders listing the Westpac, SMBC and Societe Generale proceedings for hearing. A copy of those orders was sent to Mr Panetta, and Westpac's solicitors further informed Mr Papas of the hearing date: *Affidavit of Caitlin Maria Murray sworn on 2 February 2023 (Murray Service Affidavit) (WBC/SMBC Court Book tab D.VII.40) at [53]-[54] and Annexure A (item 1) (MIN.5000.0030.0092 at 0101-0102, 0107-0108) and Exhibit CMM-30 to the Murray Service Affidavit (WBC/SMBC Court Book tab D.VII.41) at 49-51 (MIN.5000.0030.0011 at 0060-0062).*
- 7. On about 8 September 2022, SG filed its outline of opening submissions for the final hearing (SG's Opening Submissions) (SG Court Book tab B1).
- 8. Paragraph 1 of SG opening submissions referred to its proceeding "being heard simultaneously" with that of Westpac and SMBC. Those submissions were served on Mr Papas in accordance with substituted service orders: *Affidavit of Ian Timothy Bolster sworn on 18 October 2022 (Bolster 2) (SG Court Book tab D8) at [7]-[13]*. SMBC also referred to the simultaneous hearing at paragraph 1 of its submissions dated 5 December 2022 (MIN.5000.0019.0020), which were likewise served on Mr Papas:

Affidavit of Maria Yiasemides sworn on 3 February 2023 at [8]-[9] (WBC/SMBC Court Book tab D.VI).

- 9. Mr Papas has been served with all of SG's material for the hearing. Service in accordance with the Court's orders for substituted service as made from time to time of SG's:
 - (a) pleadings, evidence and draft court book index is established through Bolster 1 (SG Court Book tab D7 esp. in the right-hand column of the table summarising service at [5] on CB 1343).
 - (b) court book is established through Bolster 2 (*SG Court Book tab D8*).
