THE COURT ORDERS THAT:

- 1. By 4pm on 1 March 2023, any affidavit material in support of the application for an extension of the limitation period and submissions relied upon by the applicant in chief be filed and served.
- 2. In the event leave is granted in Chambers pursuant to r 24.01 of the *Federal Court Rules 2011* (Cth) (**FCR**) to issue a subpoena for production, or a notice to produce is served pursuant to FCR 30.28 calling for the production of documents apparently relevant to the application for extension of time, then, subject to further order, leave be granted for any such subpoena or notice to produce to be returnable before the Registrar at 9:30am on 8 March 2023.
- 3. If a notice to produce proposed to be returnable on 8 March 2023 is served, a copy of the notice to produce is to be provided to the Associate to Justice Lee within two days



of service and the solicitors for the party upon whom the notice to produce is served are to forthwith advise the Associate to Justice Lee whether there is objection to the terms of the notice to produce (in which case directions will be made for the resolution of any dispute concerning the notice to produce by Justice Lee).

- 4. By 4pm on 10 March 2023, any affidavit material and submissions to be relied upon by the respondents opposing the application for an extension of the limitation period be filed and served.
- 5. By 4pm on 14 March 2023, any material in reply relied upon by the applicant be filed and served (with the intention that any responsive submissions not only include any material in reply but supplant the submissions filed pursuant to Order 1).
- 6. The submissions filed by the parties in accordance with these Orders are to be in Times Roman 12 point-type, are to refer to any *authorised report* and medium neutral citation of any cases referred to or cited (or in the absence of an authorised report, any unauthorised report and the medium neutral citation), and are *not* to include footnotes.
- 7. Order 1 made on 9 February 2023 be varied so as to provide that the listing on 16 March 2023 commence at 9:00am.
