- 1. I am the Principal of the law firm Alexander Law which is based in Queensland and has two offices there.
- 2. I have been informed by Michael John Sophocles, and I verily believe, that Mr Sophocles has previous experience personally of giving evidence by way of an audio-visual link between the Registry of the Federal Court in Brisbane (where the witness was located) and the Court in Sydney (where the relevant trial was being conducted), that this occurred in

December 2019 and that the audio-visual link was successful in the sense that no technical complications issues arose with the link established between the two courts.

- 3. Facilities are available at my firm or our firm's associated facilities for remote access technology, including the conduct of Microsoft Teams video conferencing. I have personal experience in the use of Microsoft Teams video conferencing being conducted from my offices. My experience is that those facilities have invariably worked well in that participant in the Microsoft Teams conferences have all been able to be seen and heard clearly and that the remote access technology has not suffered from any major technical glitches].
- 4. There have been some occasions where Microsoft Teams video conferences between my offices and the Supreme Court of Western Australia have experienced technical difficulties such as inconsistent connection and freezing; however, these technical difficulties have been rectified in a relatively short period of time. In my personal experience, if and when technical difficulties do occur, it is generally at the commencement of a hearing and once the video conference is terminated in resumed the technical issues are resolved. I am only personally aware a complete failure of video conferencing on one occasion. On that occasion, the Supreme Court of Western Australia was unable to commence the video conference and legal representatives appearing remotely (from Queensland and Victoria) were unable to establish a connection. I understand this was caused by a technical issue at the Supreme Court of Western Australia and was not caused by the Microsoft Teams software itself.
- 5. I have also had experience in a 2-week trial that was conducted in the Federal Court of Australia in 2020 from Sydney where the judge had presided and I with our witnesses and counsel were in Brisbane as well as the other party were in Adelaide, and they had witnesses in Melbourne as well as the United States of America. I recall that this hearing went very well without any issues whatsoever.
- 6. I am informed by Mr Palmer, and I verily believe, that he has a copy of the Court Book which was filed in this matter on 24 January 2022.
- 7. If the Court were to order that Mr Palmer's evidence in this proceeding be given by video link from my offices in Brisbane, then I would ensure that I, and if necessary additional solicitors within my firm, would be available to resolve any technical issues which might arise, in conjunction with Court staff.
